Gloria Stewart

Mrs. Stewart said she attended the meetings on Christmas Eve and New Year's Eve and she is still in the dark. She said she had hoped with the new administration and the newly elected officials, the Council would be able to move forward. She said things were allowed by the previous administration and this administration is paying for them. She said she would like for the City Attorney and the LRO to speak up. She said she is disturbed with the back and forth. She suggested not having a meeting until the problems of taping of the meetings are resolved. She asked about the houses that were burned out on Oakwood Avenue. She said she would like to see the Council resolve the position of the Business Administrator. She asked who is the Qualified Purchasing Agent (QPA).
