## **MATTERS FOR DISCUSSION**

## Presentation by Hon Ted Green on Toy Guns.

The Clerk reported that Mr. Green would be late.

Motion to suspend the rules and have Mr. Carl Smith, the City part time tax assessor, come to the podium and explain Resolutions 15, 16- 2016 by Councilwoman Eason, seconded by Councilman Johnson

The Motion was approved by a unanimous vote.

Mr. Smith the tax collector, stated that 15-2016 allows the city to fix the rate of interest. Resolution 16-2016 is offering amnesty to the residents and he explained the reason to do it. Councilwoman Eason asked why raise the taxes and then a month later do the amnesty. Mr. Smith the tax collector explained the reasons for the timing of the amnesty and the tax increase. Councilwoman Williams had Mr. Smith confirm that the amnesty was from March 1<sup>st</sup> to April 30<sup>th</sup>.

Councilmen Johnson Jr. and Councilman Coley asked Mr. Smith about his part time status. Mr. Smith stated he works for the City around 10 hours a week.

Vice President Corbitt reported that Councilman Green had arrived and would do his presentation on toy guns.

The Council-President of East Orange Mr. Green reported that East Orange had also adopted an ordinance against toy guns after a number of incidences around the State. Mr. Green provided information on the shootings that had taken place because of toy guns and asked the Council to support the ordinance against toy guns. The toy guns now look to real and children are being killed.

Mr. Green answered questions from the Governing Body.

Acting Police Director Wade answered questions about air rifles for the Council.

The Vice-President made the following statement.
