#### CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The City Clerk made the following statement:

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to Five (5) minutes.

The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

# The following residents made comments:

- Past Council President, Ms. April Gaunt-Butler came to the podium and spoke about her concern regarding emergency services in Orange. She recalled what she had to do when she had an emergency in her home. It was the Orange Fire Department that actually responded quickly when she could not get anyone at the Police Department. The ambulance took 20 minutes to arrive. Only after the second ambulance arrived was the person taken care of because the first ambulance could not help her. She wanted to know why is there an automated system answering 911 calls in Orange. She also wanted to know the 911 routing system and where are the ambulances being housed for the Orange Community. Ms. Gaunt-Butler questioned the contract terms for the ambulances. She also asked for the standard response time for a 911 call. Ms. Gaunt-Butler thanked the Orange Fire Department for their quick response in her time of need.
- Mr. Jeffery Feld spoke about his heads up letter that he had sent to the Council Members. Thanked the BA and staff for getting the budget to the Council. Commented that his OPRA request are not responded to by the city. Provided some examples of what had not been responded to. Gave some suggestions to the Council and referred them to some court cases that they should review.
- Ms. Katelyn Gordon questioned ordinance 13-2017 language that was used in the ordinance. She spoke about the resolution that would contract Mr. Cox and how the Council should do more to prevent the sale of drugs on the streets.
- Ms. Gloria Stewart complimented the Mr. Hartwyk the City Business Administrator. Ms. Stewart provided some information on the upcoming events that the Orange students would be involved in. She asked about affordable housing.
- Mr. Tyrone Tarver thanked the Council for its support with the School Board election.

#### Responses to some of the questions by residents.

- Business Administrator Hartwyk reported that the Monarch Ambulance contract expires December 31, 2017. He will look into the issue with the automated system for 911 calls. Both ambulances should be kept within the city limits unless they are on a call.
- The Council President commented that residents may want to dial 973-266-4111 and have the police get in touch with the ambulance.
- Councilman Coley agreed with the Council President also commenting about the service that Monarch provides.
- BA Hartwyk provided information regarding an item on the bill list which concerned an employee's missing paperwork causing the fine. BA Hartwyk stated that with regards to OPRA request he would meet with the City Attorney and the City Clerk to provide a solution. Mayor's certification will be sent up to the Clerk's Office.
- Mr. Mapp provided information regarding the CAP bank, when and how it is used.
