CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The City Clerk made the following statement:

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to Five (5) minutes. The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

The following residents and business owners made comments.

Mr. Jeffery Feld thanked the Council for the public forum on water but was disappointed that it was not taped. Spoke of recent OPRA request that he had entered. Asked about the 2016 budget.

Asked about 58-2016 questioning how much money was paid on that settlement and asked about attorney fees. Commented that he was not given all the outstanding litigations as of November 2015. Spoke about his concerns regarding the WYCA negotiations.

Ms. Katalin Gordon asked about the abandoned property list and the new entry.

Ms. Gloria Stewart asked the Council to consider other times to hold their executive session besides in the middle of Council meetings. Commented that the Mayor nor Mr. Mapp were present. She would like to see the Committee meetings and other meetings should be repeatedly broadcast for the residents. Asked about 54-2016 and how that was going to work. Would like a report on recycling in the city. How is the city benefitting from recycling? Ms. Stewart made other statements regarding the administration.

Motion by Councilwoman Williams, seconded by Councilwoman Summers-Johnson, to close the citizen comments.

Council President Gaunt-Butler gave her condolences to the family that had the fire. She spoke to Attorney Smith about campaigning on city time or with city money. She stated that she sees it happening in the city. After further discussion about a memo from Attorney Smith that no one had received, it was decided that the employee handbook has a section that states that campaigning was not allowed..

Answers to some of the resident's questions.

Attorney Harris and Attorney Smith discussed a vote that had been taken and the City Clerk reported that a correction was sent to the newspaper.

Mr. Copeland stated that the budget was late due to an IT issue and that it would be delivered by April 5th. Mr. Copeland had no update regarding Acting Police Director Wade. Mr. Copeland did not have an update on appointing a Planner but may have one by the next meeting. Regarding 54-2016 Mr. Copeland provided an update on the bidding and on the expanded service of the buses. Mr. Copeland stated that a report on recycling would be ready by next week. Mr. Copeland reported that residents do have opportunities for hire on City projects. With regard to sharing the Acting BA position and shared duties. Mr. Copeland stated that the Acting BA position is a shared duty between himself and Mr. Mayes. Salaries will have to be discussed in executive session.

COUNCIL COMMENTS

Councilwoman Summers-Johnson spoke of organizations that were giving money and taking donations for the victims of the fire. She gave the dates of her quarterly Southward meetings.

Councilman Johnson spoke of the abandoned property ordinance that had been passed in 2015 and about how the administration does not discuss the status of the properties that are on the abandoned property list. Spoke of the duties of Mr. Marty Mayes and asked Mr. Copeland if he was assigned as Acting BA by Mr. Mayes or

by the Mayor's office. Mr. Copeland stated he was assigned by the Mayor. Councilman Johnson felt that the letter assigning Mr. Mayes as Acting BA, which Mr. Mayes could not produce, would have come from the Mayor's office and that the secretary should have a copy.

Councilwoman Williams gave her condolences to the May family. The Councilwoman asked Mr. Copeland about the lateness of the budget and he provided her with the reasons why it was late and what had been done so far. It was discussed by Councilwoman Williams and Mr. Copeland that the budget would be delivered on April 5th and the Councilwoman stated that late arrival will put the budget hearings behind schedule. Councilwoman Williams commented that if the administration could deliver the budget earlier than April 5th that would be helpful.

Councilman Corbitt stated that at the public forum last night that Mr. Joe Sinerger made a false statement regarding the Councilman's response time to him on the water situation in the city. Councilman Corbitt stated that he continues to find ways to raise revenue and as it relates to the abandoned properties he has to have a conversation with the law department and others in the administration. The Councilman stated that an ordinance should be drafted for the broadcasting of the meetings. He felt that the Nishuane Group had good ideas to bring revenue into the city and he felt that they should have gotten the contract and commented that they should be brought back to the city. He spoke of the disrespect toward the Council by a resident during citizens comments.

Councilwoman Eason asked if anyone had spoken to Mr. Royster to find out how the Council could help resolve the broadcasting problems. The Council needs to find out the bottom line on what needs to be done. She then asked the Acting BA to follow up on that and give the Council an answer at the next meeting. Mr. Copeland stated that he would. The Councilwoman spoke about the two fires that took place in the North Ward.

Council President Gaunt-Butler gave her condolences to the families that had the fires. She spoke to Attorney Smith about campaigning on city time or with city money. She stated that she sees it happening in the city. After further discussion about a memo from Attorney Smith that no one had received, it was decided that the employee handbook had a section that stated that campaigning was not allowed. The Council President asked that the memo from Attorney Smith be sent to her. The Council President shared her concern about the lateness of the budget and spoke of the dates that the city had missed regarding the budget. She quoted the administrations assurances about the budget being on target and on time. She spoke about the residents and the council members calling out during meetings and about mutual respect of one another. Council President Gaunt-Butler had gone to a workshop on Creative Solutions for Vacant Property and recommended that Council Members look at Trenton's 5 point plan on vacant properties.
