The Council President requested that reports be cancelled until next meeting unless there was something that could not wait.

Councilwoman Eason reported that there would be a Taco Bell opening up on Main St off N. Jefferson in the fall. The White Castle will start there rebuilding in September.

Council President directs the Clerk to file reports.

#### **Communications and Petitions:**

## **Citizen Comments:**

The Clerk read the following:

"Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to (10) minutes. The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments."

The following residents and business owners made comments:

Ms. Alexander Charles commented that the overtime for Police is excessive and the City should be more pro active in hiring Police. The water department needs a clerk to collect bills; the city needs to be aggressive with residents who do not pay their water bills.

Ms. Katalin Gordon questioned the rules for speaking during citizen comments with regard to what happened with Mr. Feld at the last meeting and questioned resolution 132-2015 (a contract to decommission well #6) the price that was accepted and why there was such differences in the contractors prices, Also questioned resolution 133-2015 (Change Order No. 1 to modify the contract for the project known as the Monroe Street Sewer Lining Project) and why there was a change order to modify the contract, along with other questions and concerns.

Ms. Gloria Stewart thanked the Council for the Proclamation and commented that the Mayor should be at the meetings. Thanked the Council for having the Senator and Assembly persons at the meeting, they were very informative.

Ms. Stewart wanted the Council to investigate other towns with regard to the sharing of water in case of an emergency. Spoke about code enforcement personnel and there responsibility regarding abandoned properties.

The Council President had City employees answer certain questions made by the residents and then went into Council Comments.

Regarding the change order Mr. Mayes provided some history of the situation regarding resolution 133-2015, (Change Order No. 1 to modify the contract for the project known as the Monroe Street Sewer Lining Project) Resolution 132-2015(a contract to decommission well #6) Mr. Mayes commented that he could not say why some contractors are more expensive than others. Mr. Mayes addressed other questions and concerns regarding those two resolutions.

Mr. Mobley explained that well #6 was replaced because it was no longer functioning and would be filled as required by law. Mr. White explained the law regarding making comments during the citizen comments as an answer to Ms. Gordon's question. There was no hard and fast rule but was determined by the situation and the litigation taking place. Mr. Harris, the Legislative Research Officer commented that Mr. Feld was not denied his right to finish his comments and explained why. The Council President answered other questions and concerns that were brought up that evening.

# **Council Comments:**

Ms. Eason reported that the Council will follow up with the Director and get new Police Officers.

Councilman Coley commented that we need to hire Police from the City's list.

Councilman Corbitt asked Mr. Mayes who cleans the catch basins after a rain storm and if we do not have a plan can one be implemented. Mr. Mayes reported that he would put one together. Councilman Corbitt asked if the City was leasing the YWCA property yet. Mr. White, the Assistant City Attorney, commented that they are negotiating an agreement with the trustee. The City is not in a lease yet. Councilman Coley questioned the soccer field at the Central playground and if it has a team that is leasing the field. Mr. Mayes will look into

that to determine if true, how the funds are being maintained and who they are going to. Councilman Corbitt reported that he was disappointed with the responses from Mr. Mayes regarding the city vehicles. Councilman Corbitt reported that there was a new city vehicle that was being taken home every night. Councilman Corbitt revisited the list of items that he was waiting on by Director Mayes. Director Mayes stated that he could provide a lot of that information but until he is named Fleet Manager by resolution to take on those responsibilities he was not taken on that responsibility. Councilman Coley stated that he would look into that and then spoke about an ordinance that he was sponsoring that evening.

Councilman Johnson, Jr. commented that he agreed with Councilman Corbitt. He did not see a reason for a Fleet Manager nor was it in the budget.

The Council President reported that Mr. Monica had been laid to rest that day and sent condolences to his family. The Council President reported that the Council President Holman of East Orange lost her mother. Council President Williams provided information of the services. The Council President reported on upcoming city events and meetings. The Council President wished all mothers a Happy Mother's Day.

Councilman Johnson commented that the bids were not time stamped by the tax collectors office. Ms. Wingfield reported that the tax department does not usually time stamp documents.

Councilman Johnson commented that there were no signatures on the documents by the Administration.

Ms. Wingfield reported that she was told that only the attorney had to sign the documents at this time.

Ms. Wingfield answered other questions from Councilman Johnson and the Council President. Councilman Johnson commented that there was adequate time for the Administration to provide all the information that the Council had requested and to sign the documents. The Councilman stated he would not

be supporting the resolution.

Mr. Mapp, the Finance Director, requested that the Council favorable consideration stating that the liens have no value to the City of Orange. The liens cannot be taken back to a tax sale, they will just sit on the City books. Once the liens are sold the City can again get taxes on the properties.

Mr. Mapp answered questions by Councilmembers. Councilman Corbitt commented that the City should have something in the contracts that states what the properties can be used for. He did not want to see a number of boarding houses coming up in the City.

Ms. Eason questioned the reason for a church to be on the tax rolls and was answered by the Assistant City Attorney.
