Reported on crime issues in the city in the past few weeks.

Reported that the Police department sponsored a dinner for the

wrestling team.

The Police department had a "bring your kid to work day". Violent crime went down 31% from this time last year.

Tax Dept. Mr. Carl Smith, Tax collector reported on 3 tax programs and their

qualifications for residents. Program applications are in the tax collector department. A folder with this information will be available.

Ms. O'Hanlon reported on the proposed budget amendments.

Reported that the Cap waiver was approved.

Public Works Ms. Gordon reported that at the last meeting they discussed Ordinance

26-2017 regarding abandoned properties.

The Clerk reported that they had received a communication from Verizon.

CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The City Clerk made the following statement:

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to Five (5) minutes.

The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

The following residents and business owners made comments.

• Mr. Jeffery Feld commented that he had sent two correspondences to the Council. Commented on the cyberattack on the City computers. He did not approve of the titles of some ordinances. Questioned what the new tax rate on amendments for the calendar year budget. He spoke of other issues he was concerned with.

- Mr. Augusta Mitchell commented that he was concerned about the city's increase to the
 water and sewer fees. He asked that all residents that will get the increase be notified.
 Suggested that before the increase that those residents have a chance to speak before the
 Council.
- Ms. Katalin Gordon Requested a status on one of her request. She wanted an explanation as to why closed session meetings are not recorded. She commented on other closed session issues.
- Ms. Gloria Stewart was pleased that the Senator and Assembly people made a presentation for the residents. Questioned if there is a need for a Director of Finance and a CFO. Asked about the school bond and the school board. She requested more security in the back parking lot during meeting nights.
- Mr. Sean Profit complained about an emergency call for an ambulance to Monarch that he made. He had to wait over 30 minutes for it to show up and he had to carry the woman down the stairs while the EMTs sat in the ambulance. He reported that another time he had waited for 45 minutes before Monarch showed up.

Some responses to resident's questions.

- BA Hartwyk commented that he would get together with the city attorney and the Fire Director to review the contract of Monarch. He will follow-up with any recommendations at the June 7th meeting.
- Council President Williams stated that Ms. Stewart will be walked to her car when she leaves. Channel 35 is still be worked on.
- The BA stated that the city is in the process of analysis of the roads to include the cost. The final report will be discussed with PSE&G, Verizon and water utilities to see if any of their projects would interfere with the road repairs.
- BA Hartwyk stated that they are also working on a 10 year and 20 year road plan.
- Director Mayes spoke about the public work repairs that are being done in the city. A list will be sent to the Council on the streets that are to be repaired this year.
- BA Hartwyk reported that the CFO position is required by Statute and that the reorganization that will be presented in June the Director and CFO positions will be combined. The Finance Director will also serve in the position of CFO.
- The questions regarding the Executive Sessions were answered by the City Attorney and the City Clerk.
