COUNCIL REPORTS

Fire – Director Douglass stated that he would answer any questions for the residency ordinance. Director Douglass provided information about the residency ordinance and how it affects his department, as he understood it. BA Hartwyk commented that the ordinance takes care of any loop holes that the original ordinance had. Chief Lone training officer for the fire department gave a report on the training of the recruits.

Police Department Sergeant Hector Rosaro, provided a summary of the week stating that they had a number of interviews for the police department, he reported on a shooting in the area. The BA reported on his staff meeting and added more information regarding the police department, stating that the police bicycle unit is up and running. He spoke about the Police Park Plan and their patrols. Council Members provided information regarding the parks and made suggestions for patrols.

Library- Councilman Jackson spoke about having Saturday library hours. He also spoke about having stable library hours during the week.

Planning – No report.

Master Plan – Mr. Haziel reported that the findings from the meeting in the South Ward are being put together and will be going out to community affairs and some focus groups to collect more data. He hoped to have a draft by the end of the summer.

Housing – the meeting was postponed – No report.

Finance – the meeting was postponed and will be rescheduled.

Public Works – the BA reported on the cross walk repairs in the city. He explained to Council the reason why there were no roadway projects in progress. There will be 2 major works and Washington Dodd area repaired in the coming months. Councilman Coley requested that the areas on Main St. that had trees that were removed still need to be filled in or plant more trees.

Council President directs Clerk to file reports.

The following residents made comments:

- Melanie Reyes spoke about Ashley Cartwright and her actions in the community. Ms. Reyes spoke about an incident with a person that was to rent an apartment from Ms. Cartwright's business. The issue was Ms. Cartwright would not rent the apartment to the woman and would not return the woman's down payment fees for the apartment for 60 days. The money should have been returned right away not 60 days later. The fee amount was in the thousands of dollars not a few hundred. Ms. Cartwright had to be taken to court for the money. Ms. Cartwright did not give back the money after the court decision to do so. Ms. Reyes wanted the residents to know what one resident did to another and to make sure that it did not happen again. The City Attorney took Ms. Reyes and the victim into another room to discuss the situation.
- Jeffery Feld reported on upcoming court date when the court will hear if there should be an investigation regarding the Mayor's brother being appointed as Police Director without a public hearing. Reported that the city had not responded to a judge regarding Feld XVI. Reported on 2 court cases regarding free speech. Reported on other items of interest to the residents.
- Gilbert Davis Commented on a disagreement that he has had with the city regarding picking up customer with his cab. He has received tickets for delaying traffic and picking up customers from the streets. He commented that the customers had called him and he had not just picked them up from the street. Councilwoman Eason stated that there is a meeting setup to discuss the matter on June 26th. Mr. Davis also commented on the Uber drivers that are picking up residents at the train station while his cabs just sit there.
- Katalin Gordon commented that there were two ordinances on the agenda that were not clear as to what they would do. She would like to know how the parking authority would work. Provided her opinion on the bond ordinance. Agreed that the library should be open on Saturday.

- Condra Gains spoke about the problems on her block and that they do not receive the services that
 the residents of that street pay for. Ms. Gains reported on many of the issues which the city
 neglects. She wanted to know who Director Mayes's supervisor is.
- Pat Arthur spoke about the referendum resolution, asked if there was a public hearing on it and that the process was not followed. Had questions about who would pay for the improvements that were scheduled to be made on the schools.
- Gloria Stewart spoke about the current board of education members and how they work with the Mayor. An elected board was voted on by the voters. She supports the passing of the resolution so if there are issues they can be handled before November. She requested a water assessment. Ms. Stewart again requested an explanation of why the city needs a Director of Finance and a Chief Financial Officer, how are they different. Reported that her grandson won the Orange school spelling bee and that Comcast's broadcast of meeting are still poor.
- Donna Arrington spoke about the fence on Seven Oaks Way and how it had been torn down but nothing else has been done to replace the fence, she would like an update. Provided information regarding broken street lights, parking issues, and bulk trash issues. Stopped 3:17:56
- Lydia Baker also had issues regarding Seven Oaks Way and the many issues. She also complained about the lack of response from DPW and the administration.
- Derrick Henry supported the weekend hours for the library. Supports the referendum for the November election.

Some of the question answered by the residents.

- Council President Williams provided information on the referendum process.
- Business Administrator Hartwyk reported that the position of CFO is a required position and the
 position of finance director is a city position. Those positions can be combined. He would have to
 investigate if an elected official could hold one of those positions.
- The Council President commented that meeting with the public and with the BOE but first we have to pass the resolution to have a reason to meet with everyone. That is what starts the process. Provided some information on type 1 and type 2 school boards and the citizen's right to have a say on taxes, she addressed other topics relating to the referendum. The seven Oaks Way issues will be investigated by DPW.
- 42-2017 BA Hartwyk provided a summary of the parking utility proposed by the ordinance. The city would not be giving up control with a parking utility as they would with a parking authority.
- The BA reported that they did not have a dollar figure on the McGovern law suit. He spoke about
 the amendment to the Central Valley Redevelopment plan stating that Lot and Block numbers had
 to be corrected.

Councilwoman Eason asked about extended hours for City Hall. The BA stated that they have extended hours for recreation sign ups in the summer. He would have to speak to the Mayor about extended hours for City Hall. Requested security for after hour programs for people leaving the building.

Councilman Johnson, Jr. reported he would be sending the BA a number of questions regarding 221-2017 that he hopes when answered will clear up some concerns.

Councilwoman Wooten reported that there would be a community cleanup on the 24th which she will be attending and working with the planters on Central Avenue. She reported that there would be a free HIV testing on June 28th at Town Hall.

Councilman Coley spoke about his water bill and how it had doubled. He investigated and found he was sent an estimate. He had the water company come out and do a reading which showed that his water consumption was much less and the bill was adjusted. Residents should check their water bills and if the amount seems high, they should call the water company. His bill went from over \$400.00 to \$7.50. Reported that parking signs were taken down when the street was repaved on Central Avenue were not put backup and it is becoming an issue. The BA will check on that issue.

Councilwoman Summers-Johnson commented that she really felt for the residents of seven oaks way and she was glad that they came to allow Councilman Johnson a chance to correct the issues. Those residents should not have to call to get basic services that are provided by the taxes that they pay. She will be working at the circle at Elmwood Drive, planting and cleaning up the area. She reported that she is sending her children to day camp and reported on some financial aid that parents can get.

Council President Williams made some public announcements. Spoke about the transparency of the referendum resolution and process. She reported that there were only 42 appointed school boards left the State. She reported on the Black issues convention in Trenton and what issues were covered. The City of Orange testified on the issue of foreclosures. Encouraged Council Members and residents to come to the cleanup day.
