# **COUNCIL REPORTS** Council President directs Clerk to file reports

- Councilwoman Williams had the Clerk announce the dates of the upcoming budget hearings and confirm that the late notice from the State regarding the late budget had been read into the record.
- Councilwoman Eason asked Director Mapp to report on the dates he would be available for the budget hearings. He reported that Ms. Knight would be at all the meetings and he reported on the meetings that he would attend.
- Councilwoman Williams reported that the Orange Housing Authority will have a ribbon cutting ceremony for phase 3 July 26<sup>th</sup>.
- Councilman Corbitt did not have any report for the Police Department.
- Fire Director Douglas provided residents with safety tips for the summer. The Director reported that he has sent 3 individuals to take arson training and 6 individuals for CPR training. Spoke about EMS complaints and who they could contact. The Director answered questions from the Council Members.
- Councilwoman Williams and Police Captain Dunn spoke about the current shooting incidents in the city and how to stop the problem.

# **COMMUNICATIONS AND PETITIONS-**

• Mr. Ike Jenkins, Essex County Liaison to Orange, reported on events and plans by the County.

The City Clerk made the following statement:

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to Five (5) minutes.

The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

The following residents and business owners made comments.

- Mr. William Lewis wished the outgoing Council Members good luck in their future endeavors.
- Mr. Lewis commented on the resolutions that concerned new positions in the Administration.
- Mr. Lewis spoke of his concerns on a number of resolutions that were on the agenda.
- Mr. Jeffery Feld spoke of his concerns on the friendly budget and recent Court decisions. Spoke about litigation that he had against the city. Named all the items that he has requested from the Administration that he had not received.

- Ms. Gloria Stewart commented about ordinances 36 and 37 asking for feedback on those and other items on the agenda. The timer for the lights on Central Ave and Oakwood need to be changed because traffic builds up waiting for the light to change. Ms. Stewart also asked for the information about the cost benefits of recycling. Ms. Stewart also spoke about her concerns regarding Director Mapp being Finance Director in Orange and Mayor of another town.
- Asked about different positions in the Finance office. Spoke about channel 35 not playing the Council meetings after the original broadcast.
- Ms. Deborah Funderburk commented that she had gone to Trenton for the talk on Education and the missing funds for the Municipalities. She felt that someone from the Council should have gone to that meeting in support of the children that the funding would help. She felt that the Council is not supporting Mayor Warren and she would like to give a team building course for the Council at no cost to help the city.
- Mr. William Hathaway thanked April Gaunt-Butler and Elroy Corbitt for their service to the city.
- He had also attended the hearing in Trenton on the school funding that had been cut and asked that the Council support those efforts by drafting a resolution of support for that funding.

# Motion to close citizen comments by Councilman Corbitt, seconded by Councilwoman Williams.

The Motion was approved by unanimous vote.

Attorney Smith spoke about some of the appeals that Mr. Feld had spoken about during citizens' comments, reporting that Mr. Feld's appeals were denied by the courts due to lack of sufficient merit to warrant discussion.

Answers to some of the citizen's questions:

The Sale of Oakwood Towers will be looked into.

- Director Mapp spoke about the Bond Council and Attorney Smith stated that an opinion will be given as to whether there is a conflict of interest with Director Mapp being a Mayor of another city. Council President stated that with regards to having the Clerk post the minutes, it is the administrations responsibility to post the minutes. The Clerk had given the minutes to the administration in a timely manner but the administration did not post them. Councilwoman Williams agreed with the Council President. The Clerk will be trained so she can add the minutes to the website. Director Mayes was asked to explain ordinances 36 and 37 and resolution 116.
- Director Mayes stated that the administration is asking that Ordinance 36 and 37 remain tabled and resolution 116 is to award a contract to OCA which will be the architect for the Recreation Center. As far as the traffic light at Central and Oakwood he will follow up with Mr. Jenkins so the County can be told. Director Mayes stated that the city received \$50,000 for the recycling from the State. Council President Gaunt-Butler agreed with Ms. Stewart with regard to having a Council Member be appointed to the Board of Education meetings. The Council President requested that Director Mayes inform the administration about the channel 35 complaint. Director Mapp reported that there are statutory positions in the Finance department. The CFO position is for a term of 4 years and is a statutory position. The Director of Finance is not a statutory position and has broader responsibilities.

- The Tax Assessor and the Tax Collector's departments report to the Finance Director. He provided more information on his positions as it relates to the administration.
- Council President Gaunt-Butler agreed with the suggestions by Mr. Hathaway and Ms. Funderburk. Councilwoman Williams commented that the Council Members have always supported the residents of the city, their educational efforts and Mr. Lee, the Superintendent of Schools.

## **COUNCIL COMMENTS**

- Councilwoman Williams asked about the McGovern Case asking if there was a trial. Attorney Smith stated that there was no trial it was a default. There was no trial date. She asked Mr. Mapp about reimbursements on the bill list for Memorial Day. Mr. Mapp did not know of any and then was told that there was an event but details would be given at a later date. She asked about the phone companies that were used.
- Ms. Knight reported on the reasons for multiply phone companies. Councilwoman Williams questioned Director Mapp on other bills that were on the bill list. Director Mapp will get back to Council on the additional \$10,000.00 amount for the cleaning service and if it had come before the Council for approval. The Councilwoman thanked Councilmen Corbitt and the Council President for their service.
- Councilwoman Eason spoke about the Rec Center and giving the children something to do.
  Councilwoman Eason asked Mr. Feld to stop with the law suits that the city has to keep paying
  for while he keeps losing his cases. That money could be donated to the school district and be
  used for the children. The Councilwoman asked for volunteers with skills that they could bring
  to the Rec Center. Councilwoman Eason thanked Councilmen Corbitt and the Council President
  for their service.
- Councilman Johnson thanked both Council Members for their service and reported on the upcoming Orange High School graduation date and location. He asked which budget was the bulk tax lien added to, the 2015 or 2016 budget. Director Mapp stated that money from the sale went into 2015 surplus. Councilman Johnson questioned the \$70,000 that the YWCA owed the city from water liens and will that money be in the 2016 budget as anticipated revenue. Director Mapp stated that at the closing all money matters should be settled. The Councilman thanked Councilmen Corbitt and the Council President for their service.
- Councilman Coley questioned Carl Smith about the money owed by the YWCA. It was
  determined that the legal documents had to be reviewed before the Council could get an answer.
  Councilman Coley questioned Director Mayes about items on the bill list and maintenance on
  abandoned properties. Councilman Coley asked if the city can continue to operate without a full
  time tax collector. Director Mapp stated that it is common to have a part time Tax Collector as
  the city does with Tax Collector Carl Smith. The Councilman thanked Councilmen Corbitt and
  the Council President for their service.
- Councilman Corbitt reported that he had gone to Trenton to represent the Council and to give testimony on the lost funding for the city schools. The Councilman congratulated the new Council Members. Councilman Corbitt reminisced about his first days as Councilman and thanked the residents for having faith in him. He assured the residents that he was a community guy and would be staying in touch.
