The City Clerk reported that there were no OPRA reports.

COUNCIL REPORTS

- Councilwoman Williams reported that depending upon the outcome of the Local Finance Board meeting there may be a need for a special meeting in July. Councilwoman Williams reported that she had to leave the meeting at 6:30 that evening.
- Councilwoman Eason reported that there would have to be two meetings in July, one for the budget amendments and one for the passage of the budget.
- Councilwoman Summer-Johnson reported that she did not get the information from the Library that she had asked for and she was still waiting.
- Fire Director Douglas reported on the Fire Safety Campaign for the summer. The Fire Dept is looking for applicants for the Fire Department. Director Douglas reported on other activities of the Fire Department. Director Douglas answered questions from the Council Members.

• Councilwoman Williams asked the Mayor to have an ordinance for the Organizational Chart submitted for review by the Council.

• Acting Police Director Wade reported that the Orange Task Force along with other Task Force are working together to stop crime in Orange and the neighboring towns. The Director answered questions from the Council.

The City Clerk reported that there were no communications or petitions.

The City Clerk made the following statement:

"Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to (10) minutes. The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments."

The following residents and business owners made comments.

- Mr. Jeffrey Feld commented on upcoming court dates where his augments would be heard against the City also commented on resolutions that had typos and items that he would be reporting to the Local Finance Board when they had their hearing.
- Ms. Jackson reported on the noise pollution that takes place in her neighborhood around Elm St. Residents play loud music all summer and into the late night even after the Police have come to their houses.
- Ms. McPherson of Elm St. also commented on the loud music that is affecting her quality of life.
- Ms. Katalin Gordon made comments regarding the Sunshine Law. Ms. Gordon spoke about the vacant and abandon properties ordinance.
- Ms. Lauressa Bradshaw spoke about the need for a cost analysis of the YWCA, and listed
 the lost revenue by the city. Ms. Bradshaw commented that unless the violence stops in
 Orange the Transit Village won't bring in any revenue.
- Ms. Kimble reported that she was representing the residents of Watchung Avenue. Ms. Kimble had a petition which requested that certain areas of Watchung Avenue be made residential parking only. This would prevent the patrons of Castaways from parking in driveways and taking up all the parking spaces on the streets. The patrons throw garbage on private property and fight in the streets. Ms. Kimble also spoke about the hazard to children and residents of that area and the rudeness of the patrons.
- Mr. Black of Watchung Avenue also reported on issues he had with Castaway patrons
 and suggested new parking hours for that area. Ms. Eason addressed some of the issues
 that were brought up and reported on some ideas that would work for everyone in the
 area including the establishment Castaways.

Motion by Councilwoman Summers-Johnson, seconded by Councilwoman Eason, to close the citizen comments.

Responses to some questions and concerns.

• Question regarding Resolution 188-2015 interest. Mr. Mapp could not answer questions regarding resolution 188-2015. It was determined that it would be discussed when the resolution was walked on.

- Council President Gaunt-Butler referred to the YWCA \$100,000.00 payment and asked if it could be clarified that it was a 'lease with the option to buy'.
- Attorney Smith commented that the resolution that was passed had the statement that it was a lease with the option to buy. Attorney Smith continued his comments by recounting all the inaccurate statements that had been made by Mr. Feld currently and in the past.
- The Council President requested that Acting Police Director Wade comment on the issues of
 noise pollution within the city. Acting Director Wade provided information on what the Police
 department was doing and will do regarding the issues which included the problems with
 Watchung Ave.
- Mr. Mayes, Director of DPW, answered questions regarding abandoned properties and the
 ordinance for abandoned properties that were on the agenda. Mr. Mayes reported on the current
 personnel that would be working on abandoned properties. Mr. Mayes gave an update on 240
 Lincoln Ave.
- Ms. Cooper, the City Chief of Staff reported that Mr. Mobley had taken on the responsibility of
 the parking meters and that 420 parking meters needed to be replaced, the project is going out to
 bid and she hopes to have a request to the Council by August. Ms. Cooper also reported that the
 cost benefit analysis for the YWCA is still being worked on and most information will be
 available in August.

COUNCIL COMMENTS

- Councilwoman Summers-Johnson commented that she was upset to hear about the issues that Watchung Avenue was having and was glad that it was brought to the Council's attention. A life guard had passed away this summer and there would be a Lisa Watts Day at all the pools in July.
- Councilwoman Eason asked that 197-199 N. Day St area be maintained by DPW.
 Councilwoman Eason asked Mr. Mayes, the Director of DPW, about the legislation for the Tax Liens regarding the cleaning up of abandoned properties. Mr. Mayes reported it was still being worked on. Councilwoman Eason gave her opinion on the fines that the city proposed for abandoned property owners stating it was too large.
- Councilman Johnson, Jr. thanked the citizens for coming to the meeting. Councilman Johnson requested that the Council support the ordinances 35and 36 2015.
- Councilman Coley thanked the CBAC for all their hard work on the budget. He commented that those that were sentenced to Community Service could be taking care of the abandoned lots in the City. Councilman Coley asked for an update on Reock St and Hickory St issues. Mr. Mayes reported that the issues were being worked on. Councilman Coley reported that in the past the loud music on Elm Street had been handled by issuing a ticket and once the Police were called back to an address the second time the Police removed the amplifier from the premise. Coley asked about the money the City received on the tax liens. Mr. Smith, the City Attorney, commented that the information would have to be discussed in Executive session.
- Councilman Corbitt met with the Engineer and Mr. Mayes regarding Watchung Ave to determine which signs could be posted which will help to correct the issues there. Councilman Corbitt commented on Black on Black crime and how the County does not get upset with it; then

commented that some good legislation needed to be passed. Councilman Corbitt stated that we need to take back our streets. Councilman Corbitt will speak to the Mayor about having more Directors come to the Council meetings so there can be more cooperation. On July 13th a meeting and presentation will be given at St Matthews with utility and trash vendors along with the Board of Education and the Orange Housing Authority. All residents are urged to come to that meeting.

- Councilwoman Eason commended the Superintendent of Schools and the School District for getting off the list of schools that need improvement. The Councilwoman also noted that the Administration needs to be more responsive. Calls and questions go unanswered for two to three day because no one is there to respond to the Council's request and questions.
- The Council President thanked the residents for coming to the meeting and thanked the other Council Members for electing her President. She stated that she plans to work with the Administration. The Council President asked that the Council representatives and Liaisons to write their reports and have copies for the residents.
- Attorney Smith gave the reasons why Executive Sessions need to take place at times.
