The City Clerk announces that the requirement of N.J. S.A. 10:4-9 et. seq., "Sunshine Law" has been met a public notice was sent to the Star Ledger and published with the Record-Transcript on August 18, 2016, posted on the Bulletin Board in City Hall and filed in the Office of the City Clerk.

The Clerk stated that the purpose of the meeting was to consider a resolution authorizing the foreclosure of tax title liens in rem.

• Mr. Jeffery Feld asked why the City isn't selling the tax liens. Mr. Feld asked about the bill list.

• Mr. Bruce Myer came to the podium and commented that he had nothing to say about this resolution because of what he had experienced with prior tax liens and how badly they were handled.

• Ms. Abrams asked if there is somewhere is can find the total of all the abandoned houses and properties. Is the property that is being sold going for the market value, how is that determined.

Council President Williams asked the residents that had shown up late if they had any questions regarding the resolution for foreclosures. There was no reply.

Motion by Councilwoman Summers-Johnson, seconded by Councilwoman Eason to close citizen comments.

The Motion was unanimously approved.

- Council President Williams asked Mr. Mapp to answer the question about the bill list not being on the website. Mr. Mapp stated that the individual who maintains the website will have to determine why the bill list was not being viewed. When asked if he had given the bill list to that individual to put on the website. Mr. Mapp did not know and would have to get back to the Council. Councilman Coley asked if there was a procedure by the Administration to get the bill list to that individual and if not, they should put one in place.
- Council President asked the Acting Business Administrator about having things added to the website. Mr. Hartwyk stated that once the bill list is provided as part of the agenda it would be added to the website immediately that day. Mr. Hartwyk stated that the properties that were added to the foreclosure list that their liens were originally offered for sale in 2014 or 2015 and there were no buyers therefore the city retained the liens on those properties. After the City retains those liens for 2 full and ¾ of the third year they are permitted after 3 month from the last lien sale to place those liens on the rem foreclosure list. Mr. Hartwyk went into further detail about the foreclosure list and the authorities that permit the sale. Mr. Hartwyk answers question by the Council Members.

The Clerk read the resolution as amended by title. The amendment is the last sentence in the first paragraph "being scheduled number 1 through 17 "not 18.
