COUNCIL REPORTS

- Councilwoman Wooten reported that there was a ribbon cutting ceremony for Water G. part III which she attended that day. There would be a golf

outing the following Monday which is a fund raiser for children and students scholarships.

- Councilman Jackson reported that there was a Planning meeting last month and they approved a plan for the establishment of a Senior Citizen day center on Washington Street.
- Director Douglas came to the podium commented on the preparations that had been made for the storm that missed our area. Director Douglas spoke about the brown outs in the fire departments and fires that the department responded to. The hydrant inspections are 80% completed. He reported that a good number of hydrants are out dated so the hoses will slip off the hydrants with water pressure. The Director updated the Council on the hiring of new firefighters. The month of October is Fire Prevention Month and he reported what the Fire Department is planning to do.

Council President directs Clerk to file reports.

COMMUNICATIONS AND PETITIONS

Mr. Jenkins, the Essex County Liaison to Orange came to the podium and explained what the Liaison from Essex County does for the Cities in Essex County.

Councilman Johnson requested a list of Director Appointments so the Council can act upon them.

CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The City Clerk made the following statement:

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to Five (5) minutes.

The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

The following residents and business owners made comments.

- Mr. William Lewis reported that Ms. Smith died and provided the Council with some facts about her life. Spoke about the City issues with one way streets and how he feels that the issue should not have come to the Council. Spoke about school incidents and commented that tax payers are paying 20% more than they should.

- Mr. Jeffery Feld spoke about the \$10,000.00 and that the bill list and agenda had not been posted on the website. He commented that 2015 audit was not on the website. Mr. Feld spoke about other concerns he had concerning the City.
- Ms. Abrams spoke about a contract for sewer pipe repairs and commented that people watching the Council meetings can see the Council Members playing with their cell phones and she felt it was disrespectful. Ms. Abrams also stated that when an attorney comes to the meeting to replace the City Attorney they should be able answer questions that are asked of the Law Office. There should be a file prepared by the City Attorney of items that will be talked about.
- Ms. Gordon questioned the need of 3 newspapers that the City uses.
- Ms. A. Meyers spoke about a back to school event that was held on the 21st of August. She questioned when will the road on William St be repaved and also asked when they will be getting the speed bump that was requested.
- Ms. Gloria Stewart thanked Director Douglas for all the good work he is doing with the Fire Department. Ms. Stewart commented about all the talented students that live in Orange. Asked if something can be done to spruce up the school building next to the Walter G complex. The people that move in to those apartments will want their children to go into a nicer looking school. Asked questions about the Library. She also reported that the Main Street Liquors employees are rude to the residents and do not speak English.
- Ms. Bernadell spoke about the many issues that Ogden Street has and in particular the alternate side street parking that is every day, and requested that the number of days be reduced. She had spoken to DPW for three years about repaving the street because of the pot holes. The block needs more lights to stop the W. Orange boys from braking into cars and going into the abandoned house. The Police are not responsive. Ms. Bernadell stated that the new Rec Center is dirty, the bathrooms are filthy the rooms smell of mildew.
- Mr. W. Sheppard spoke of the traffic on Haywood Avenue and how his taxes had gone from \$8,000 to \$13,000. There was an abandoned car that was on his corner for 6 months before the car was removed. His street is not swept by the City and people are selling drugs by the Heywood school. The quality of life in Orange is horrible. The Council is not doing their jobs.

Responses to some of the questions

- Councilwoman Summers-Johnson stated that the City Council is aware of the issues on Heywood and the Police are addressing them. Council President Williams stated that Councilwoman Summers-Johnson has been very diligent in her work to have the issues that Mr. Sheppard spoke about taken care of.
- The Council President stated that Mr. Hartwyk, the Acting Business Administrator, would be addressing the lighting, abandoned house and paving the street on Ogden Street. The concerns about the Rec Center should be addressed by the City. Mr. Hartwyk stated that there will be a parking study throughout the City to address parking issues.
- Council President Williams suggested that Ms. Stewart write the Better Business Bureau regarding the Main Street Liquor store. They are very good and follow up on complaints. We can also bring it up to the Chamber of Commerce.
- The Council President commented that street paving is done on a schedule and with the new Business Administrator the city will be able to have a schedule put in place. Mr. Hartwyk stated that a plan is being created for paving of the city and it has to be done on a capital basis. Director Mayes should be able to address pot holes on Williams Street rather quickly.
- Clerk Lanier stated that the third newspaper is a backup plan. The two main papers that are used is the Star Ledger and the Transcript. If the deadline is missed for the transcript then the Star Ledger is used.
- Mr. Hartwyk provided information about the insurance for the sewer pipes and stated that the program is voluntary. You do not have to buy that insurance.
- Council President Williams stated that with regard to the attorneys that represent the City Attorney when he cannot be at a meeting, they may or may not know an answer but they should be given the chance to find out the answer. They cannot anticipate the questions that may be asked. Council President Williams explained that the cell phones can be used to take notes and we should give people the benefit of the doubt.

COUNCIL COMMENTS

- Councilwoman Summers-Johnson commented that after the shooting, any park that she went to had a Police presence and if it did not she called and had a Police person come to the Park. Councilwoman Summers-Johnson spoke about the drugs that had entered the city and how residents can help to stop the drugs. The Haywood school

and Lincoln Avenue roadways and drug issue will have a forum to determine a course of action.

- Councilman Jackson said that crossing guards are also needed. The lighting in the South ward should be addressed.
- Councilwoman Eason and Councilman Coley will speak to Acting BA Hartwyk about the crossing guards at Haywood. Councilwoman Eason suggested that Police could put in a total of 4 hours a day for Haywood as a second job which the Board of Education could pay for. The Councilwoman also reported that Mr. Lee, the Superintendent of School is still on the job and his contract is coming up for renewal for another three years. Councilwoman Eason also spoke about properties that are abandoned. Director Mayes stated that in order to keep track of abandoned properties the city needs to hire someone that can dedicate their time to monitoring and reporting issues to the DPW. Acting BA Hartwyk stated that he and Director Mayes are working on a report regarding abandoned properties for the Oct meeting.

- Councilman Coley commented that the traffic light at Main Street and Oakwood had to be repaired and possibly moved. It had been knocked down 4 or 5 times over the years. Councilman Coley pointed out some of the resident's concerns and stated that the Administration governs those issues.
- Councilman Johnson asked Director Mayes to take signs down that are around the city that are high on the poles.
- Councilwoman Wooten thanked Director Mayes for his efforts on issues that she had spoken to him about. She will call the Housing Authority to see if they can do anything about enhancing the properties around the Walter G. development. She and other Council Members are planning a Meet and Greet with residents and Police Officers.
- Council President Williams stated that the election is 60 days away and the last day to register is October 18th. The Council President asked Acting BA Hartwyk to assign Police to events and have them stay there for the entire event. Council President Williams asked about the Orange hotline. Councilwoman Eason stated that the hot line was for recreation. Acting BA Hartwyk will research it and report back to the Council President. Acting BA

Hartwyk stated that the Table of Organization will be presented to the Council on the 20 of September or the first meeting in October. Council President Williams asked the Acting BA to bring the reconciled list of properties that were on the bulk sales list to the meeting. The resolution for the sale stated that the sale had to take place within 30 days of passing but the sale took place after that and the Council is looking for a legal opinion on how that can happen.
