MATTERS FOR DISCUSSION

Discussion on Best Practice

Director Mapp gave a summary of the City's best practice responses. The purpose of the report is to insure that Municipalities comply with State regulations. The City needs to get a score of 80% to receive State aid. The City did score 80% so it will receive State aid. The City had received 8.3

million dollars in State Aid. Director Mapp and BA Hartwyk answered questions from the Council Members

The resolutions and ordinances to be presented at tonight's meeting are listed on the attached Regular Meeting Agenda. If any Council Member wishes to discuss any resolution or ordinance, it may be discussed at this time.

- 375-2016 Councilman Coley would like a better solution regarding abandoned properties.
- 372-2016 Councilman Jackson questioned the dispose of damaged and antiquated equipment by the Police Department. BA Hartwyk stated that the items cannot be reused or sold.
- 373-2016 Councilman Jackson questioned if this would include traffic light timing to better move traffic through the city. BA Hartwyk stated that the company does not handle traffic light timings.
- Councilman Jackson asked what are the plans for the properties once the resolution has passed. BA Hartwyk stated that the properties will be rented or sold.
- 308-2016 Councilman Jackson asked about option 2 on the resolution. BA Hartwyk stated it was a multiyear contract with options.
- 381-2016 Councilman Jackson asked if the digitized documents would be available online. Clerk Lanier stated that once the City's IT infrastructure is capable of handling the online documents they will be added to the website.
- 382-2016 Councilman Jackson questioned the contractual reimbursement. BA Hartwyk provided Councilman Jackson with the reason.
- 382-2016 Councilman Coley provided reasons why the Monmouth-Ocean Hospital Service Corporation was not a good fit for the City.
