If they check only Agenda Items or General Issues, they will be allowed to speak for five (5) minutes. MATTERS FOR DISCUSSION

Presentation of plaques

Councilwoman Eason read and presented the family of Gregory Dillon Sr. with a plaque in memory of Mr. Dillon's life and accomplishments. The family members thanked the Council for the plaque and kind words. Each Councilmember made comments of their experiences with Mr. Dillon.

Councilwoman Jones-Bell read and presented the family of Colin Magloire with a plaque in memory of Mr. Magloire life and accomplishments. The family members thanked the Council for the plaque and kind words. Each Councilmember gave their condolences to the family members.

Ms. Wendy Sykes made a presentation on Affordable Health Care Act providing dates of enrollment, outside enrollment events; also reported on expanded medicaid enrollment procedures and dates.

Council President Williams reported that if residents had any questions that were not answered here tonight by the presentation they could contact Ms. Sykes at Town Hall.

RESOLUTIONS AND ORDINANCES

The Deputy Clerk read the following statement: "The resolutions and ordinances to be presented at tonight's meeting are listed on the attached Regular Meeting Agenda. If any Council Member wishes to discuss any resolution or ordinance, it may be discussed at this time."

- 1. Councilman Corbitt called for Ordinance 8-2014 and questioned some items that he felt were missing from this bond ordinance such as resurfacing of specific roads in Orange and having central air installed in the Town Hall building to save on the City's electric bills. After hearing comments from Fire Director Dowd and DPW Director Mayes Councilwoman Eason suggested that one million dollars be added to the bond Ordinance to provide for 2 needed fire trucks and other items. Director Dowd answered questions from the Councilmembers. Councilwoman Gaunt-Butler commented that the Administration needs to provide the Council with a graduated plan of maintenance so replacements can be planed for and not have equipment just fail and need to be replaced immediately.
- 2. Resolution 79-2014, the Bill list was called for by Councilwoman Eason. Finance Director Mapp and DPW Director Mayes answered questions regarding specific items on the Bill List.

The Motion by Councilwoman Jones-Bell, seconded by Councilwoman Gaunt-Butler to adjourn the Conference meeting was unanimously approved at 8:23 p.m.
