- Question: Who represents the South Ward? Stating matters are brought to the table and no one comments or addresses those concerns. Further stating, the South Ward bares 42% of the tax burden.
- School System: Level 3 monitoring; 2 new principals in Heywood Avenue School.
 Still school rating declined.

Jeff Feld stated his concerns as follows:

- Share sentiment of the lack of City Attorney presence.
- · City Website minutes are not posted.
- Error on Block and Lot that he caught on resolution. Who's reviewing resolutions for accuracy?
- Resolution 216-2013 (Bill List): Why was it not posted on the website?

Katalin Gordon of 211 Park Place stated her concerns & inquires as follows:

 Resolution 213-2013: Does not reflect previous data. Also indicating, now there is a loan in place?

 What month was the last month the Council received a report from the Administration?

- Pilot Programs: Stating her concern with increase in residents verses safety
 measures because the Police and Fire Department are not properly staffed. What
 is their plan for the discrepancy in staffing verse developer research data?
- Concerned with Council's lack of power in retrieving data/reports from the Administration? Further inquiring if the Council has called up Consumer Affairs for assistance?
 - Councilman Marable responded to Ms. Gordon's question concerning the reports: stating a financial report was provided in April. Further commenting that Council has gone to extended measures to receive reports from the Administration.
 - Council President Eason echoed Councilman Marable in that Council has exhausted extensive measures to receive reports from the Administration. Seeking counsel from Consumer Affairs and the City Attorney. Adding, if anyone can provide resolution(s) to receive reports from the Administration they are open to follow-up.
 - Marty Mayes, Director of Planning and Public Works responded to Ms. Gordon concern as to the inclusion of a loan in Resolution 213-2013.
 Stating, Is the loan predicated on the grant? No, the loan serves as a match dollar for dollar of \$600K. For the remaining #300K, the funds are coming from the CDBG Grant applied for in 2012.

Richard Bryant, Exec. Dir. Of Valley Arts, 580 Forest Street:

- Announced upcoming Hats City Street Festival (sponsored by Valley Arts) June 15th 2013, 11am to 9pm; Showcasing various artist throughout the day with twenty vendors and four galleries.
 - Councilwoman Jones-Bell stated she was excited about the HATS Festival and personally invited her family and friends to support the event.
 - Council President Eason inquired into the hours of the Stage Performances. Reminding Mr. Bryant of the residency community surrounding the festivities and informing Mr. Bryant of the many disturbances of the peace complaints that have come before Council. Further inquiring about, the level of Police presence and participation for proper safety measures.

Gloria Stewart of 62 Hampton Terrace stated her concerns as follows:

- · Recycling: How do residents/city benefit?

 Police Director Simms indicated the Police Department is not staffed properly. In review of the budget, did Council consider additional staffing for the police department?

- Oppose statement made by resident Mr. William Lewis that the South Ward bears the brunt of the taxes. Adding the East, West and North also share in the tax burden.
- Would like 2008 comparison to 2013 Budget and Salary Ordinance.

 Shared and directed her comments to resident Gloria Stewart that efforts are being made for Council and the Administration to work together. As well noting, the Administration and Council met and discussed options for bringing on a Business Administrator.

Councilwoman Gaunt-Butler:

- Question: Do we know the status of 400 Oakwood Towers?
 - Council President Eason responded no. Further stating, the City Attorney has not followed up and will initiate follow-up herself.
- Question: Does the Council know the status on Parking Permits for the residents on Alden Street?
 - <u>Councilwoman Williams</u> commented even though permits are displayed tickets is still being issued.
 - Council President Eason asked Police Director Hakim Simms: Are all police officers aware of the Resolution and Ordinance updates?
 - <u>Director Simms</u> replied yes and disseminated throughout personnel.
 Ensuring Council that he will follow up to ensure updates are implemented.
- Invited the community to attend the unveiling of the Plaza for Cotton Funeral Home Director, June 18th, 2013 at 3:45pm.

Councilman Marable:

- Thanked all present Directors for attending the Council Meeting. Specifically noting
 personnel that are not present: City Attorney, Fire Chief (because we don't have
 one), City Clerk (has not been for 2 1/2 years... Give a few appearances here and
 there), Chief of Staff, Finance Director, Mayor and of course there is no Business
 Administrator because we don't have one.
- Expressed concern with who is responsible and/or searching for a new Business Administrator. Stating the search should have started eight months ago when the Council rejected the Mayor's choice for a Business Administrator.

 In closing in response to a comment about non-responsiveness of the South Ward Council Person, Councilman Marable stated he is the Councilman for the South Ward and is not aware of issues that have impacted his ward that he has not addressed.

Councilman Corbitt:

- Requested an update on the light outage on Lincoln and Central Avenue.
- Requested an update on the One Way Signage for Taylor and Pierson Streets.
- Commented on the Bill List item in question regarding the Breakfast held at the Elks Lodge. Stating he would like to think the event was not politically motivated; citing senior residents from more than senior buildings attended the event.
- Supports the renovation of the High/Alden and Central Playground/Baseball Field.
- Commented and echoed the sentiment of resident Gloria Stewart on continued comparison of the South Ward verses other Wards. Stating he would like for the comparisons to stop for the betterment of Orange.
- Announced the upcoming Fundraiser at Lincoln Avenue School to aid the students in their trip to the Netherlands.
 - <u>Council President Eason</u> added the school committee would like for each Council Member to make a donation to help send the Robotics Team to the Netherland.
