City Council President Eason recognized Mr. Bashir.

Mr. Bashir shared what is happening at the Orange Fitness Center, 50 South Center Street, 973-851-6899.

- Recently the center had an acclaimed boxer work with the center.
- o The center has 5 boxers anticipating upcoming 2013 Golden Gloves.
- Hoping to work with the City's approval, they are planning a 200 youth March Against Obesity.
- They are also planning a debutante ball in June to honor elected officials.
- The Center offers a free work out for residents 1 night a month.
- He works closely with kids who work with DYFS and parents.
- He is asking for financial or other way of supporting the Center support for any way he can. More importantly he wanted the city to know what is happening.
- o 50 blankets have been donated and they were given to the youth of Orange.
- They believe that the youth in Orange need more encouragement. The need more empowerment and believed that. If any questions about the program, he does left flyers.
- o Doors open everyday from 4:00-7:00pm.
- This is for kids who want to do good and they continue to give them power. We extend ourselves to the community.

Council President Eason recognized Councilwoman Jones-Bell.

 Councilwoman Jones-Bell stated she may be able to help out with some of the gowns for the ball.

Council President Eason recognized Councilman Marable.

- Councilman Marable commented that in his recent communication regarding.
 - Support for the Orange Fitness Center, there is a tight window of time so if there is a willingness to support, please respond by tomorrow.
 - He urges all to respond by contacting the administration in that regard.

Council President Eason recognized Jeffrey Feld

Jeffrey Feld, Municipal Stakeholder, 268 Main Street, Orange, NJ, 07050.

He has posted on the city's www.NJ.COM public website for comments and questions. He is shocked as to what has been going on with the tax abatement issue. Refer to today's Star Ledger regarding:

- Notice today, that the City of Plainfield has a public year, that their audit for the public year 2011 has just been noticed.
- Plainfield did not make their payments to the county. He reviewed the Plainfield public website and pulled out agendas he reviewed. In the agenda, monthly operating and how much income comes in a month. Concerns about monies getting paid.
- He felt that there is something strange about getting paid money.

Tax Abatement

Mr. Feld addressed his concerned about the Emergency Tax Abatement.

- Regarding the Open Public Meetings Act, was their ample notice to the public regarding the emergency tax abatement meeting.
- A report, Abate Addiction: A case on Jersey City's Municipal Tax Abatement that was done by a professor Jonathon Wharton, Ph.D. at Stevens Institute. It speaks to the abuses regarding tax abatements and since there is hearing possibly taking place on Friday, he is very concerned about how we handle our tax abatements (see attached).
- He has not had the benefit of looking at documentation; financial statements
- He stated to be very careful about the Tax Abatement.
- When we have judgments and settlements how much money have we paid out and where is the money coming from.
- He cautioned and questioned which statue, would we be operating under to give a tax abatement.

Council President Eason recognized Bruce Meyer.

Bruce Meyer, 500 Berkeley Avenue. Mr. Meyer is concerned about the 30 year tax abatement.

- He is one of the 20% of Orange residents that own a home and pays taxes, he has been paying not only his share, but part of the business' taxes. When one is talking about giving a 30 year tax abatement, that is his money that the city is giving. He believes he is subsidizing the tax abatement.
- This has been discussed and going on for years. Now that it is an emergency is "hog wash". This was never publicly disclosed. The only persons who is going to loose money are the owners of the business that have been subsidized and making a profit for the past 30 years.
- He does not mind businesses making a profit if they are doing good business and other property owners are subsidizing these businesses.

- They do not have to pay as much taxes. The business owner states that he cannot maintain the upkeep of the building.
- Well the homeowner is in the same boat. How many cannot paint their homes; nor fix it. How many are living on the edge; and can't afford the house and getting foreclosed. Again, we are in a situation where it is the business and its profits; which is 60% of this town. The homeowners are subsidizing them.
- This item is brought up at the last minute. If one votes on it, tax abatement this and if you vote on this. Tonight, if you go ahead and vote on this and capitulate to this and not think it over, and as far as he is concerned, this is a dereliction of duties.
- He believes his money is being used inappropriately by throwing it at a company and their profits; and having a manufactured last minute crisis. It is the business who makes money and it is the homeowner who is getting stuck in the end. This can't be manufactured. We can't do things like this.
- Certain things have to get done and if they can't get done, figure out a way to do it right.

Council President Eason recognized Charo Pierre

Charo Pierre, 493, Valley Street; Orange, NJ expressed a horrible situation of crime that her son, 14, Kajon Pierce Laws faced. She has been a resident of Orange, NJ since 2003.

- On 2/26/2013, after getting off the school bus at the corners of Central and Lincoln in front of OPA, 4:15 pm, Kajon was held up at gunpoint.
- The assailants tore off his shirt and placed a gun to his head. One man in the front and one in the back. They demanded that Kajon, give them his Dr. Dre headphones. He was punched.
- When he was safe, he called her and she told her son to call 911 and told him she would do the same. She does not have a vehicle so she ran out of the house. She flagged down Officer Joseph Lane. Officer Lane took the report while Kajon sat in the police vehicle he was petrified. He gave the report while his classmates went home. After Officer Lane was done with the report, he then drove them to the place of the crime scene.
- The one phone call no parent wants to receive. "Mom, they have a gun placed at my heart." She commented that when a gun is in the hands of someone who does not respect life, it is very bad.
- She is here because she wants to change the bus pick-up location. Her son is terrified. Since then he catches public transportation; he has not been the same.
 The other bus students have asked him if there is anything she can do.
- She is asking that the bus stops be changed to Central Avenue at Walgreens and the other at Nasau and Scotland roads. She is asking for the safety of her son and asking for the safety of other students. Changing it from one of the worst corners in Orange.
- She has contacted the Principals of both Pride Academy and (OPA) Orange Prepatory Academy.

- She has visited City Hall in hopes of meeting Councilman Edward Marable. She received a call back from the principal of Pride Academy, Ms. Thomas and the secretary of OPA; Ms. Dockery; and a call from Ms. Deedra Dobbs, who works for the Board of Education.
- However, the bus stop still remains at the same location...because of some red tape.
 The person who is responsible for the location of this bus stop should be ashamed of
 himself. Half of the children live further than Walgreen's. The other half live near
 Scotland and Nasau.
- These are your children too. She prays that after tonight that the person who is responsible for making a conscious decision, the bus stop be changed immediately. If it is not, the message that we are sending out is that we do not care about their safety nor welfare. These children ride a bus which is paid for by the District of Orange.
- o She is not only a concerned parent, but she is a taxpayer and voter.
- She lives in Orange, she shops in Orange. Please let the person who is responsible to bypass the red tape and make a change that will help the students. Can the children receive a police presence from 4:00-5:00pm, or escort...to ensure the safety and welfare of these students? She will be at every City council meeting until this matter is resolved.

Council President Eason stated:

REGULAR MEETING

- Her apologies and agreed that the location could/should be changed.
- Yet, she asked for time to resolve the matter. She stated the mayor has committed tomorrow to meet with Board of Ed., Superintendent Lee.
- She asked for her phone number.

Council President Eason recognized Mayor Warren

Mayor Warren stated that he will meet with the Director of Police tomorrow 3/6/2013 regarding the attack.

Council President Eason recalls that at one point there was a police presence at that corner. Yet if an emergency call were to come in, the officer would have to leave. The issue will be revisited.

Council President Eason recognized Katalina Gordon:

Katalina Gordon, 211 Park Place, Orange, NJ

Discussed a 2/19 Matter of Discussion - Gun Control Concerns

- A student Najee MCEachin, who was a Mayor for A Day student, had spent time in Law Enforcement. He spoke of gun buy back issues and lack of money for the Police Department.
- She believes that the City Council should consider taking a stab to eliminate guns in the city. She does not want guns to be "carried" in the city. Orange would not be the 1st to legislate such a firm stance on gun control. Please think about it.

Water Quality Issues

- In reference to the United Water Presentation by Robert Galanti, she thanked Council Woman Jones-Bell for stating that the water quality is not up to stuff and the water taste lousy. The Valley area has been selected as a Federal superfund site. The last time for voter presentation that was not the case.
- o There are 2 wells pumping up water from that very same area, the Valley.
- She was stunned that no member of the council is questioning about the quality of such a sewer. There are maybe about 50 areas in the whole nation that are superfund sites.
- This area being one of those and drinking water coming from there, "This is a no brainer" regarding quality concerns.
- She mentioned aspects of water quality. She is troubled about the lack of interest asking council to look deeper.

Tax Abatement

She had specific questions regarding the Tax Abatement – emergency meeting.

Council President recognized Councilman Marable

Tax Abatement concerns

 She has concerns regarding Tax abatement issues she agrees whole hearted with Bruce Meyer and questioned the length of time of tax abatement.

Council President Eason recognized Mr. Robert Beckelman

Mr. R. Beckelman is a lawyer for Greenbaum, Rose, Smith and Davis. She inquired as to if he could respond to Ms. Gordon's question.

Attorney Robert Beckelman responded.

- Referred to the Warehouse Claus of the resolution approved under the Limited Dividend and Housing Entity Laws. The Warehouse Claus is amended by
- When the long term exception law was adopted; it specifically preserved grievances entered under that law. The repealer did not apply to that law to the extent there was an agreement in place. When that law was adopted, repealing the old statues, specifically stated public law, "1991 chapter 431 Section B", an entity organized and operated appealed shall not be affected by that appeal, any financial agreements or extended any taxes shall not be affected by that appeal. This situation is still operating under the Limited Dividend Entity Law for the term of the agreement. That law did not required adoption by ordinance.
- The original agreement was for a term for about 30 years. It was tied to a FHA mortgage or 50 years.
- 1991 repealed should not be affected by that appeal and tax should be extended through mutual written extent.
- Law is currently in effect until March 16, 2013. It would expire before the next council meeting. It is extendable on the basis of the original law that it was adopted. The Municipality can extend that agreement.
- Ms. Gordan is troubled that the renewal of tax abatements. She believes it creates a
 precedent that the City of Orange is continuing new tax abatements. We just can not find
 the money.

Council President Eason, recognized Gloria Stewart.

Gloria Stewart, 62 Hampton Terrace, an Orange resident.

She also can feel the pain for Ms. Pierre, the mom of the son who was attacked.
 Something similar happened to her son when he was 15. She stated that counseling is beneficial.

Water Issues

 Regarding the water, she hopes the council keeps an eye on United. She is not comfortable drinking the Orange water.

Oakwood Ave

• They are demolishing the apartment buildings on Oakwood Ave. to start a project.

City Bills

- Regarding "bill" meeting; she wondered if it would create a problem if the city waited until the 19th.
- She was blown away to note that another 10 years may be added to the already 30 year abatement. She asked, "Why are we waiting until the 11th hour." This could have been better.
- How does this benefit the city? You may have residents that will encounter problems, regarding the tax abatement. She would like an explanation regarding the tax abatement.
- o The BA situation, how has it been impacting the empty seat things?
- Outgoing Clerk, she was shocked when one is trained and then one leaves the city.

Council President <u>Eason</u> introduced potential legislation sponsored by Councilwoman Williams regarding individuals getting trained and then leaves the employment of the city. This item should be on the next agenda.

Council President Eason recognized Marty Mayes.

Council President Eason recognized Councilwoman Williams

Councilwoman Williams

- She is troubled about the format in which it was presented she is confident that the finance committee regarding a multi-component development will pay attention. One component of this is affordable housing.
- This property is an isolated situation, senior or disabled tenants are on a fixed income. Most tenants are in a narrow income situation seniors or disabled citizens. The rental units may not evolve to where other than those who are on fixed incomes would be living there.
- The administration called a meeting with the finance committee to vet out the financials.
- The mayor has already agreed to put together a senior advisory committee, and, an advisory board that would meet quarterly.
