REGULAR MEETING MINUTES November 5, 2014

THIS WAS A REGULAR MEETING OF THE CITY COUNCIL OF THE CITY OF ORANGE TOWNSHIP HELD IN THE COUNCIL CHAMBERS, CITY HALL, 29, NORTH DAY STREET, ORANGE, NEW JERSEY, ON WEDNESDAY, NOVEMBER 5, 2014, IMMEDIATELY FOLLOWING THE CONFERENCE MEETING.

Councilwoman Summers-Johnson introduced Ms. Tamia La'Naysia Tyree from Orange High School who leads the assembled in the pledge of alliance.

Vice President Coley and other members of the Council thanked Ms. Tyree for coming to the Council meeting.

The Deputy Clerk then did a roll call.

The Council President asked for a motion to approve the minutes from September 16, 2014.

The Council President reported that there were no OPRA Reports.

The Council President then asked for Council reports.

Councilman Coley - Public Safety report - No report. Housing Authority report - No report.

Councilwoman Eason – Planning Board – The Board approved a design for a new White Castle. It will be closing in January and will be reopening in the summer. A.B.C. report – The Board is still working on some solutions.

Councilman Corbitt - Fire Department - No report.

Councilwoman Summers-Johnson - Library report. Last week Councilman Corbitt, Councilwoman Gaunt-Butler and she had attended a Domestic Violence Program, providing some detail on subjects that were touched upon during the program. There would be a change in the way the Library reports are given to Councilwoman Summers-Johnson. There would be a South Ward Community meeting at the Heywood Ave School on November 12th from 6:00 P.M. to 7:00 P.M.

The Council President reported that on November 10th from 7:00 P.M. to 9:00 P.M. there would be a book signing by author Jeff Hobbs. There would be an Executive Closed Session that next evening, November 6th, to discuss personnel issues starting at 6:30 P.M. The Finance Committee will be hosting a budget forum presenting the status of the City's spending for 2014 on Nov 13, 2014 starting at 6:30.

The Council President directed the Deputy Clerk to file the reports.

The Council President reported that there were no communications or petitions at this time.

CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The Deputy Clerk made the following statement.

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to (10) minutes.

The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

The following residents and business owners made comments.

Mr. Lewis of Orange NJ commented that the South Ward residents pay 42% of the City's taxes.

Mr. Lewis commented that there is a lot of talent in the South Ward which is not being used.

Mr. Lewis gave some background of his work experiences.

Mr. Lewis commented on the need for the CBAC at this point in time.

Mr. Feld of 268 Main St commented that he hoped for a speedy recovery for the Police Officer that was shot in East Orange. Mr. Feld commented on a resolution that he had delivered to the Council members regarding having the State provide the City with a State monitor because of the financial situation in the City.

Mr. Feld commented that not one Council member would support that resolution. Mr. Feld and the Council President had a discussion on what could be spoken about during the General Comments section of a meeting. Mr. Feld asked that the Council look at the Local Finance Notices that had just been released. Mr. Feld touched on other topics.

Mr. Monasehiam of 339 Main Street commented that he has owned that property for twenty seven years and that in recent history there has been a change; the good economic balance that used to exist does not exist anymore. He spoke of the increase in the tax rate and real-estate taxes being increased to the point where many owners may have to leave Orange. Mr. Monasehiam sent out the following notice and had a meeting were owners and residents decided to create this Petition which was sent to owners and residents in Orange.

We are the residents, shoppers, taxpayers and business owners of Orange. We like our Town; we shop here, live here and want to see Orange thrive. A strong and vibrant City needs a variety of businesses and shops that can be successful. This cannot happen if the way that the city is managed results in increases in Real Estate Taxes to the point that our local businesses and residents are seriously considering leaving. We Hereby Request that the Administration and the City Council work together with the State of New Jersey to properly manage our City's financial affairs and to reduce Real Estate Taxes so that all of us can continue to enjoy all that Orange has to offer." This petition was signed by over 425 owners and residents of the City.

Ms. Katalin Gordon, 211 Park Place, commented that she would like to have a public hearing on OPRA response times. Ms. Gordon commented on the audit report from last year's Corrective Action Plan. Asked questions regarding some answers that were on the Corrective Action Plan. Made comments and asked questions regarding resolution 289-2014 the Open Space Trust Fund with regard to Colgate Park. Stopped at 1:22:46

Mr. Monasehiam came back to the podium and reported for the record that Mr. Wolfe, from the City Attorney's office, was one of his tenants.

Ms. Darleen Sample of Orange commented that the streets, sidewalks, lines on the streets and street meters have not been taken care of and wanted to know where the money was going to. Taxes are being paid but she cannot see any improvements in the above things.

The Council President asked for a motion to close citizen's comments.

Motion by Councilman Corbitt, seconded by Councilwoman Summers-Johnson, to close citizen's comments.

Citizen's comments were closed by a unanimous vote.

Mr. Mayes, Director of DPW was directed to answer question for Ms. Sample. Council President reiterated the questions that Ms. Sample asked and asked Mr. Mayes for a status. Mr. Mayes reported that Main street was due to be painted shortly, this year there were 6 streets that were worked on, when the weather is better they will do another 5 streets. Any specific streets of concerned should be reported to him. The city is ordering new signs. Mr. Mayes gave a summary on what his department was working on for the New Year. Mr. Mayes made other comments regarding repairs. Colgate Park is a remediation project from a Block Grant Program.

The Council President asked Mr. Mapp when the application for the loan was made for Scafar which had been rescinded by the Council. Mr. Mapp recalled that it was late spring early summer of last year.

The Corrective Action Plan items were asked about by the Council President which Mr. Mapp addressed those items and commented on the improvements that the City has made in this current plan. Mr. Mapp commented that most of the items that are in progress will be corrected by the next Corrective

The Council President suggested that the Council members keep the list that came with the Bond Ordinance of items that would be purchased under the bond ordinance and compare it to the forthcoming resolutions for equipment.

Council comments:

Action Report.

Councilman Corbitt commented on the stakeholders and property owners that were at the meeting and concerned about their recent tax increases and that he remembered that in 2006 the homeowners had come to a meeting because they had received tax increases on their properties. He believed that whatever calculations that are used by the State needs to be addressed. Councilman Corbitt had it confirmed that the two 16 passenger vans that were requested are replacing what is already in the City inventory. Councilman Corbitt directed Mr. Mayes to have a property cleaned of trash on Haywood. Regarding the City time clocks he would like to know if management will also be clocking in as is required by other employees. Mr. Mayes was not aware of the plans for the time clocks.

Mr. Mayes will get him an answer.

Councilwoman Eason reported that on Friday night from 6:00 P.M. till 9:00 P.M.at the Lincoln Avenue School there will be a zumerthon. It will be a \$10.00 fund raiser for the Booster Club. She commented with regard to Ms. Gordon's complaint about response times for her OPRA request stating that the Clerk's Office has to wait on the Department/s that have the information for the OPRA. Councilwoman Eason remarked that the Budget that was presented to the Administration by the Council was not adhered to and that is why the residents are seeing their tax increases. She asked the residents to help the Council to get the Administration to stick to the Budget amounts that the Council presents. Councilwoman Eason also commented on the time it takes for DPW to comply with request saying that they take too long to respond. Councilwoman Summers-Johnson commented that she agreed with Councilwoman Eason with regard to the timely response of OPRAs. She commented that she could not get use to having people come to the podium and speak angrily to the Council. Councilwoman Summers-Johnson said she will represent her Ward to the best of her abilities but she will not be yelled at by people who come to the podium. Councilwoman Summer-Johnson reminded residents about the South Ward meeting she was having for her Ward on November 12th at 6:00 P.M. for an hour.

Councilman Coley commented on some repairs that he saw in the City by DPW. He thanked Mr. Mapp for the Budge worksheet and asked some follow up questions which were answered by Mr. Mapp. Councilman Coley suggested a hearing on OPRA request for the Council. He asked Mr. Mapp if he would be using the time clock. The Council President stated that the Council would have to make legislation on a policy. Councilman Coley commented that a few months ago he was told that there would be a reduction in taxes and that he has an increase instead and asked how that happened.

The Council President spoke about her concern with residents that speak out of turn during Council meetings. She commented on how the budget items would be reviewed at the upcoming Budget meeting The Council President reported that only 29% of registered voters in Essex County voted during the last election and how positive changes could take effect if more of the Orange residents would vote. The Council President spoke about the dedication of the Councilmembers and how they are working with Administration to ensure that they are serving the citizen in the most effective and efficient way. Speak to your Council person all the time not just when you come to meetings. Opra request are responded to long before the due date if the information is coming from the Clerk's Office. Information coming from other departments in City Hall are the late responders to OPRA request. Training on OPRA issues is on going in

the Clerk's Office. The Council President invited all residents to the Budget meeting on November 13th at 6:30 P.M.

Mr. Mapp commented that the tax reevaluation resulted in the erosion of the value of property by some two hundred million dollars. The tax rate is a function of all properties and the tax rate this year of \$4.45; without the revaluation the tax rate would have been \$3.86. Mr. Mapp provided more stats for the residents regarding the tax rates now in place.

The Council President asked if anyone from the public would like to be heard.

Mr. Feld commented on his concerns for Scarfar and asked if there was a change order authorizing this amount; is there a resolution approving a settlement for this amount. Mr. Feld commented on other concerns regarding this Bond Ordinance. Mr. Johnson, the Bond Council for the City of Orange, addressed most of Mr. Feld's concerns.
