If you are a registered voter in a municipality of Essex County, other than the City of Orange Township, and have moved to the City of Orange Township, but did not submit a change of address to the County Commissioner of Registration, **you are entitled to vote in the Orange Municipal Election on May 8, 2018.** Go to the Polling Place of your new residence and request a Provisional Ballot. However, first **confirm that you are a registered voter.**

ASSISTANCE FOR PERSONS WITH DISABILITIES

Persons unable to vote at the polling place due to permanent or temporary disability may request a vote by mail ballot application by telephoning the Office of the County Clerk at (973) 621-4922. The Office of the Board of Elections may be contacted for information regarding polling place assignments and assistance to voters who choose to vote at the polling place on Election Day. The telephone number is (973) 621-5073.

Pursuant to the provisions of the "Voting Accessibility for the Elderly and Handicapped Act of 1984" a telecommunications device for the deaf (TDD) is maintained at the Election Division, Department of the State, Trenton, New Jersey.
