## **COUNCIL REPORTS**

Finance:

Council woman Williams presented her Finance Committee minutes to the Council and proceeded to provide a report on the last Finance Committee meeting and their recommendations. City Attorney Pennington addressed Resolution 58-2018, he had Attorney Dorsey and his Law firm partner come to the podium and Mr. Dorsey spoke about the opioid literation and what their Law firm is doing to stop the opioid epidemic. They hope to have pharmaceutical companies come forth and explain why they lied about the addiction of their drugs to the doctors that were prescribing those drugs. Why did they encourage doctors to over prescribe those drugs? He further described their suits and how they will help the city to recover some cost associated with the opioid abuse within the city. They answered questions from the Council Members. The City Attorney stated that there will be no cost to the city regardless of the outcome of the suits and if they win, the law firm will only receive 25%. Mr. Dorsey stated that the law firm will be updating the City Attorney on all major developments.

Councilwoman Williams had Director Mapp come to the podium and asked him to make a brief statement about Resolution 38-2018. Director Mapp reported that the resolution is required by the State to be adopted annually and provided information on the cash management plan. Director Mapp also spoke about the award of contracts and the requirements to set aside the funds stated in the contracts.

Councilwoman Williams asked that at the next meeting the Business Administrator speak about those that prepaid their taxes for 2018 in 2017 and if they will be able to get the benefit they expected. They had discussed the Housing Authority and the properties that they are purchasing. Councilwoman Williams had the Tax Collector answer questions regarding PILOT programs. The Tax Collector reported that as soon as there is a PILOT she should be notified so the property can be taken off the books immediately. Councilwoman Williams asked for an update on the repairs for Freddie Polhill Law Complex as soon as possible. She had Director Mayes come to the podium and had him speak about the Urban Essex Coalition for Smart Growth. Clerk Lanier gave an update on the Council's website.

  insulated and how well is the heat regulated in the senior buildings. She also asked about tax
  sales and how to know when they are coming up.
- Mr. Walter Elliott spoke about residents of Orange that have done well.

The Business Administrator spoke about the temperatures and stated that average age of the buildings was about 35 years old but he could determine the insulation of the buildings. The city reviewed the complaints about the buildings before making suggestions on the temperature limits. The city will be monitoring the buildings to see if some changes need to be made. The tax sale was advertised on the website and advertised twice in the newspaper prior to the sales.

## **COUNCIL COMMENTS**

- Councilwoman Summers-Johnson spoke to Valley Arts and Valley vendors to create a neighborhood watch. They have been working with the Police. The Valley has been broken into seven parts with Captains in each. A meeting will be held February 27<sup>th</sup> or 28<sup>th</sup> she will confirm the date in the future. The immigration rally was well attended. For students going to college she requested that residents donate a "Bed in a Bag" for their college rooms. In March she will be having a Community meeting for single parents. She reported that the seniors in her ward who own homes feel neglected by the city because they miss many events that are advertised in flyers that they do not receive. Councilwoman Summers-Johnson asked all South Ward seniors residents to call older adults in City Hall so they can be put on the call list for upcoming events.
- Councilman Johnson, Jr. reported that he would be sending the Business Administrator emails on issues from the West Ward.
- Councilwoman Williams spoke about the tour she just took of East Orange General Hospital
  and her experiences at the hospital as a young volunteer. She spoke about the Legislative
  Committee that she and Councilwoman Eason are on. She commented on the two new
  legislations that are being considered, the creation of a State Bank and Net neutrality. She
  reported that there will be computer classes for older adults starting March 1<sup>st</sup>. She requested

that the flyer with that information be added to channel 35. She commented about Black History month.

- Councilwoman Wooten reported on upcoming events in the city. She had attended the Dignity
  Immigration Rally and asked that everyone wear orange on Friday in support of the Orange
  youth. She asked that everyone check on the elderly in their neighborhood during these cold
  days. She provided information about the new features within East Orange General Hospital.
- Councilwoman Eason read a poem from East Orange High School. She reported that the League needs representation from Essex County. Senator Codey and Senator Gill are introducing a bill to assist small businesses with financial help. She asked the Business Administrator for a bus schedule for the seniors. She asked for an update on the OMEBA contract. The Business Administrator stated that there is a draft of the contract that will be retroactive from January 1 2017. It should come to the Council once the City has a budget. Councilwoman Eason asked about reflective vest for the city workers. Director Mayes stated that the employees get 2 vests. She also asked that information of what type of work needs to have permits be added to the city website.
- Councilman Jackson spoke about positive changes and Black History Month. He also spoke
  about having more police patrols for parking meters and how the City is losing money from
  all the cars that park and do not pay the meters.
- Council President Coley requested an assessment of all streetlights that are not working from Director Mayes. He also reminded apartment dwellers to get apartment insurance.
