#### IX. PENDING BUSINESS

HPC Brochure – Grant – development of the content.

Commissioner Wells advised that the brochure is being reviewed.

The Secretary advised that the Nishuane Group has scheduled a draft Master Plan presentation for August 6, 2018.

Commissioner Wells inquired about sending the HPC brochure with the tax bill. Attorney Bauer advised that the Mayor instructed her to do a notice pursuant to the Municipal Land Use Law relating to change in zoning. Attorney Bauer advised that in her view, notification is not required because the designation of the districts did not change any zoning classifications or zoning boundaries. Nevertheless, Attorney Bauer prepared a notice as instructed by the Mayor and the Secretary has presented it to administration; the Tax Assessor deferred to the Administration for direction. Attorney Bauer advised that sending out the HPC brochure would not satisfy the notice requirement, if notice was required, and that the bigger problem is that the applications are not being sent the HPC. Attorney Bauer recommended to the HPC that a meeting be scheduled with the Administration.

Commissioner Wells inquired about the Planning Board approving the demolition of the property on Crane Street, which is a historic building built in 1939 and as to why it did not come before the HPC. Commissioner Simmons advised the HPC that there are some properties in the historic

district that are getting remodeled and the HPC is not getting notification. Attorney Bauer suggested members attend the Planning Board meetings for coordination purposes.

Commissioner Simmons inquired as to how the HPC will distribute the brochure if it does not go with the tax bill. Commissioner Morrell confirmed with the Secretary that Councilwoman Williams was the person who requested that the notice from the HPC be included with the tax bills. Commissioner Morrell expressed disappointment in the Administration for not following a directive from the Municipal Council. Commissioner Simmons will be following up with the Administration to schedule a meeting.

The Commission briefly discussed the upcoming August 15, 2018 meeting, which may be cancelled due to a lack of quorum.
