The Clerk reported that the resolutions and ordinances to be presented at tonight's meeting are listed on the attached Regular Meeting Agenda. If any Council Member wishes to discuss any resolution or ordinance, it may be discussed at this time.

Councilwoman Eason regarding Ordinance 43-2018 asked Attorney Marlin Townes what he found out about previous question concerning HUD properties. Mr. Towns stated that rentals do not apply to HUD subsidized residents, federal regulation pre-exempts, and State laws do not apply to HUD in buildings.

CONFERENCE MEETING

Councilman Jackson regarding Ordinance 47-2018, an ordinance amending the ordinance of certain blocks in Orange. He questioned if the Ordinance is being driven by the Master Plan and what is the strategy. The Business Administrator, Mr. Hartwyk stated it is driven by the Master Plan in part and the preservation of the neighborhood. Zone was A2 as oppose to AA. Any existing two and three family homes will be grandfathered in.

With regard to Resolution 287-2018 Councilman Jackson asked what is the savings with natural grass. The Business Administrator said saving in maintenance cost of wear and tear. Director Mayes confirmed it is for the maintenance. Final stage for High and Alden Street Park. Litigation regarding company providing artificial turf – wants to confirm this is not the same company. Director Mayes advised he was not aware. The Business Administrator confirmed it is the same company but now they own the entire manufacturing company. Field Turf now controls the whole process. Company has done job for various notable companies around New Jersey. Company has donated to Bell Stadium.

With regard to Resolution 288-2018 the Councilman asked if the company was going to be providing tires to the whole City? The Business Administrator said they are.

Councilman Johnson- with regard to Resolution 286-2018 wants to know if the additional \$1,740.10 exceed \$50,000.00 limit. The Business Administrator stated that this was an additional amount, making the total sum \$51,740.10.
