COUNCIL REPORTS

- Finance:** Councilwoman Williams read into the record the Finance Committee Minutes. Outstanding report due for Handicap parking and Ord. 60 and 61-2018.
- Planning:** Councilwoman Eason – Planning Board – there was a meeting were they discussed and approved the Master Plan. Councilman Johnson requested that Councilwoman Eason to explain what is the process when a project is being memorialized. She explained that they discuss it and by memorializing the project and set forth the changes to be made. Councilman Coley inquired if the Planning Board provides the City Clerk with minutes. Councilwoman Eason advised that the secretary has been ill and they are in the process of replacing her, but all of the minutes are being recorded. Councilman Jackson stated that there should be minutes available for the Planning Board meetings.
- ABC:** Councilwoman Eason advised that there is a gentleman’s club opening on North Day Street and the ABC Board is inquiring where they obtained their liquor license.
- Library:** Councilman Johnson will be attending the next meeting. Councilman Jackson advised library will not be meeting in December but a letter was sent out providing progress of library. Councilman Jackson invited director to attend next meeting but has not received a response.
- Housing:** Councilwoman Williams reminded council that there were a few members who retired and resolutions will be forthcoming. She will have a report at the next meeting.
- DPW:** Kaitlin Gordon advised there was no meeting since city administration was not in attendance.
- Police:** Director Warren appeared and advised on 12/5/18 interviews will begin for positions and over 600 people were feed during Thanksgiving. Mock trial was conducted and received positive feedback. Wrestling program will begin this month but no date available. Provided City Clerk will applications. Toys for Tots is being planned.
- Councilwoman Williams inquired about some shots that she heard on Chapman Street and wants to know the process for the report taken. Director Warren provided the Council with the process carried out to prepare report from incident. She wants to know what is the benefit of the investigation.
 - Councilwoman Williams advised that Ted Green and Mayor Baraka had an immigration discussion and would like to know when there will be a partnership.

- Councilwoman Eason commended the Orange Police Department stating that the police officers are busy in the City of Orange making their presence. Requested lights be placed for Christmas.
- Councilwoman Summers-Johnson thanked the Police Department for helping clear out an accident in front of Hayward Avenue School during the storm.

Fire:

- The Fire Director reported that the Fire Department had 2,435 runs for the year.
- On 12/3/18 a car jumped the curb at 300 Mechanic Drive and an individual lost a leg. He also Commended Newark Fire Department for assistance in securing the building.
- On 12/2/18 he Councilwoman Wooten and Summers-Johnson attended community meeting at 65 Randolph. The tenants reported on safety issues and the Fire Department conducted inspections. Safety checks will be done on the 30 units. He reminded residents they can call (973) 266-4230.
- On 11/29/18 there was a Fire inspector examination hosted by Orange.
- On 11/22/18 they hosted their gift to give thanksgiving event.
- Toy drive will take place in December date to be determined.
- Hosted forum for Orange High School students who are looking to enter the medical field.
- Council Member Williams commented on an incident she had in her apartment when she left her oven on and fell asleep.
- The Director advised an oven should not be used to warm up an apartment. You can call the Fire Department if you don't have any heat.
- Council Member Jackson thanked the Director for what was done on Thanksgiving and for inviting the Council.
- Councilwoman Eason wanted to know the status of the ambulance matter she had brought up. Director advised the Ambulance representative attended a meeting but was not able to speak. The Bids for EMS service contract is due.
- Council President Coley inquired as to the status of the repair/replacement of fire hydrants. Requested he provide a list at the next meeting. The DPW would have to provide an update on the repair and replacement.

CITIZEN COMMENTS ON GENERAL ISSUES/AGENDA ITEMS

The City Clerk made the following statement:

Pursuant to section 4-10 of the Code of the City of Orange Township, each person addressing the Council shall step up to the microphone, shall give his or her name in an audible tone for the record, and unless further time is granted by the presiding officer, shall limit his or her address to Five (5) minutes.

The public is expected to conduct themselves in a proper manner, any derogatory, abusive or threatening statements will not be permitted. The Chair will immediately rule such conduct out of order and terminate any further comments.

The following residents and business owners made comments.

- Mr. Jeffrey Feld delivered heads up memo on 12/03/18 to council and city officials.
- Extended a get well wish to the BA.
- Concerned about the Best Practice presentation as compared to last years.
- Reminded Council about his outstanding OPRA requests, more importantly the FBI subpoenas. Expressed his concerned about the tax abatements reports.
- Advised City should look into tax lien sale.
- Commented on the Request for Proposals for Budget Consultant and wants to know if it is for the City or Municipal Council.
- Wants to know how much money is being paid on the Juliano settlement.
- Ms. Gloria Stewart – inquired as to why the Finance Director was selected to fill in for the BA. She commented that as it relates to the School and the Police Department the city should be working together as a team. She was concerned that she was told that the Council does not have to respond to questions.
- Ms. Karen Wells – heard the residents will now be able to pay their taxes on line with their credit cards. Wants to know if it has commenced?
- Mr. Gus Mitchell – reminded the Council that he has come there before to ask why some people who have other State license plates are allowed to get parking permits. Previously, the BA advised he will follow-up but has not. Inquired as to what can be done to resolve the situation.

Motion to Close Citizen Comments by Councilwoman Williams, seconded by Councilwoman Summers-Johnson

All were in favor.

- Capt. Dunn, Orange Police Dept. does not believe there are people with out of state plates have parking permits. 877-553-7283 you can call to report if there are people with out of state plates.
- Mr. Chris Mobley – it is possible that there are people with out of state plates that have a temporary parking permit. There are two possible instances: (1) if a person relocates from another state a temporary permit can be given for 30 days, and (2) if a student who is out of state in college returns home for break. Council President inquired how many out of state plates permits have been issued? Mr. Mobley advised legislation will be prepared to reduce temporary parking permits from 60 days to 30 days. If they cannot obtain the New Jersey state plates, they can apply for another 30-day extension. Capt. Dunn advised there is state law that requires individuals to change their address when they relocate within 14 days.
- Councilman Jackson inquired what is on the face of the permit.? Mr. Mobley stated temporary permit.
- Director Mapp stated that you cannot pay your bills with a credit card online at this time. There will be an RFQ next week for a vendor and they are looking into Edmunds online software.
- Council President Coley explained that other cities have less time for citizen's comments not that he was thinking of shortening the time of citizen's comments.
- Mr. Mapp stated that the Best Practices will be posted on the website.
- Councilwoman Williams requested that the Clerk get the Board of Education statement.

- Councilman Jackson stated that there was only a comment about the Best Practices and there will be a public hearing on it in the near future.
- Clerk Lanier – RFQ – Budget Consultant is for the Municipal Council.
- Councilwoman Williams had the City Attorney confirm that there were subpoenas received by the City and is working with the City Clerk.

Councilwoman Summers-Johnson:

- Thanked the Fire Department for their thanksgiving dinner
- Question for Public Works – landscaper in South Ward – what is the protocol for landscapers?
- The next South Ward meeting is scheduled for 1/24/18 at Our Lady of the Valley Church.

Councilwoman Williams:

- Unitarian Church is a non-profit. Asked Aaron Wilson the Tax Assessor to work with Director Mapp to look into a situation at the Church regarding being taxed. Mr. Wilson stated that a Non-profits must do a further statement every three years.
- Councilwoman Williams inquired if the City will be doing anything for the day of mourning for President Bush. Director Mapp said no. Director Douglass advised that he will have the flags lowered.
- Encouraged the community to be helpful with the Affirmative Action Committee.
- Councilwoman Williams advised that the City now has a lease with New Jersey Transit and is now responsible for the garbage at the Highland Avenue train station.

Councilwoman Eason:

- Lincoln Avenue School has put together a parent academy from 10 a.m. to 2 p.m. for 12/13, 12/14, 12/15, and 12/16.
- Orange High school will be putting on their play.
- Confirmed school board members cannot incorporate curriculum for the schools that is done by the state. The schools are not overcrowded.
- Would like for Council President to reconsider responding to resident's answers in real time.

Councilman Jackson:

- Agrees about real time answers for some questions but not all. Some items need to be researched or thought about before they are answered.
- Encourages residents to reach out to him at 862-240-3634 or the city to seek answers and not entertain rumors. He also gave his e-mail address.
- He is looking forward to a timely budget for 2019.
