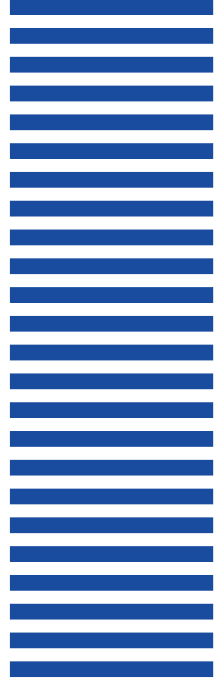


NO PERSON SHALL SERVE AS A BEARER FOR MORE THAN THREE QUALIFIED VOTERS IN ANY ELECTION.

To Protect your Vote:

It is against the law for anyone except you the voter to mail or transport this ballot unless the envelope is sealed and the following is completed before the ballot is taken from you. Ballot mailed or transported by:

No person who is a candidate in the election for which the voter requests this ballot is permitted to serve as a bearer. No person shall serve as a bearer for more than 3 qualified voters in any election. Bearer must present valid I.D. with name, address and signature when delivering a ballot.

REMINDER – For your vote to count, you must:

1. Vote your ballot and place it in the inner envelope with the attached certificate.
2. Seal the envelope. Complete and sign certificate.
3. Place the inner envelope into the larger envelope addressed to the Board of Elections and seal that envelope.
4. If another person will be mailing your ballot or delivering it to the Board of Elections office, MAKE CERTAIN THAT PERSON COMPLETES THE 'BEARER PORTION' ON THE ENVELOPE ADDRESSED TO THE BOARD OF ELECTIONS BEFORE THE BALLOT IS TAKEN FROM YOU. NO PERSON WHO IS A CANDIDATE IN THE ELECTION FOR WHICH THE VOTER REQUESTS THIS BALLOT IS PERMITTED TO SERVE AS A BEARER.
5. Mail to the County Board of Elections as soon as possible. If RETURNING YOUR MAIL-IN BALLOT IN PERSON IT MUST BE RECEIVED BY THE COUNTY BOARD OF ELECTIONS BEFORE CLOSE OF POLLS ON ELECTION DAY. If RETURNING YOUR MAIL-IN BALLOT BY MAIL, IT MUST BE POSTMARKED NO LATER THAN ELECTION DAY AND RECEIVED BY THE COUNTY BOARD OF ELECTIONS NO LATER THAN 48 HOURS AFTER THE TIME OF THE CLOSING OF THE POLLS FOR THE ELECTION.

RECORDATORIO – Para que su voto sea válido, usted debe realizar lo siguiente:

1. Coloque la boleta en el sobre interior con el certificado adjunto. Debe completar el certificado.
2. Selle el sobre. Complete y firme el certificado.
3. Coloque el sobre interior en el sobre más grande dirigido a la Comisión Electoral y selle el sobre.
4. Si otra persona envía por correo su boleta o la presentará a la Comisión Electoral, ASEGÚRESE DE QUE ESA PERSONA COMPLETE LA PARTE CORRESPONDIENTE AL "PORTADOR" ("BEARER") EN EL SOBRE DIRIGIDO A LA COMISIÓN ELECTORAL ANTES DE LLEVAR LA BOLETA. NINGÚN CANDIDATO EN LA ELECCIÓN EN LA QUE EL VOTANTE PIDIÓ ESTA BOLETA SERÁ PERMITIDO A SERVIR COMO PORTADOR.
5. Si devuelve su boleta en persona, debe ser recibida por la Comisión Electoral antes del cierre de las urnas el día de la elección. Si devuelve su boleta por correo, DEBE TENER EL SELLO POSTAL A MÁS TARDAR A LA COMISIÓN ELECTORAL POR LA COMISIÓN ELECTORAL A MÁS TARDAR 48 HORAS DESPUÉS DEL MOMENTO DEL CIERRE DE LAS URNAS ELECTORALES.
