Stanziale, LLC., 552 High Mountain Road, Ste. 3, North Haledon, New Jersey (hereinafter referred to as "Counsel");

WHEREAS, the City of Orange Township agrees to retain special counsel on behalf of Dwayne D. Warren, Mayor and David C.
