WHEREAS, the City of Orange Township, New Jersey mourns the passing of **Daryl André Harrington**; and

WHEREAS, we come together during this time of sadness to pay tribute to and celebrate the life of **Daryl André Harrington** who was a vital and central force in his family and valued member of the community; and

WHEREAS, **Daryl André Harrington** was born on September 21, 1967 in Orange, New Jersey, the only child of the late Brenda J. Harrington and oldest son of the late Terrence L. Marable. He was educated in the Orange Public Schools, and later graduated from Essex County Vocational High School in 1985. He went on to attend Bloomfield College where he majored in English; and

WHEREAS, **Daryl André Harrington** went on to work in many capacities for the City of Newark and Proctor & Gamble. However, his most recent position as a Supervisor for Delta Global Services garnered him several Employee of the Month awards and the love of not only his immediate co-workers but also of Leadership in DGS, Delta Airlines and Port Authority organizations; and

WHEREAS, **Daryl André Harrington** was immersed in the Christian community that would be his lifelong support from an early age. As a young child he attended Union Baptist Church in Orange, New Jersey. In adulthood, he rededicated his life to God when he joined the Mount Olive Baptist Church in East Orange, New Jersey in 2001. There he served as a Deacon for many years. He later returned to Union Baptist Church where he answered God's call to become a Minister on December 20, 2015 and served on the Church Community Outreach Ministry; and

WHEREAS, **Daryl André Harrington** had a great love for his community and a special passion for the City of Orange, where he was born and raised. He coached both youth baseball and football, was a community activist, served on the City of Orange Citizen Budget Advisory Committee, Oakwood Avenue School PTA, and most recently as a Co-Organizer for the Oakwood Ave Community School Boys Mentoring Program. He was also an active member of the Oranges & Maplewood Unit NAACP, as the Chair of Religious Affairs (2009-2014) and Political Action Committees and became a proud Silver Life Member in 2014; and

WHEREAS, **Daryl André Harrington** entered into eternal life on April 18, 2020; and

WHEREAS, **Daryl André Harrington** is survived by: wife, Tara L. Williams-Harrington; children, Erika S. Harrington, Bryanna A. Harrington, Latasha M. Jordan, Jason J. Alford, and Gregory T. Richardson; uncle, Arthur H. Harrington Jr.; sister, Kim G. Walker; nephew, Kenneth L. Grant Jr. and a host of other family and friends.
