#### **COUNCIL REPORTS:**

Councilman Johnson, Jr. inquired about the use of the Orange Public Library building.

Business Administrator Hartwyk advised the library is closed per the Governor Murphy's Executive Order. In a State of Emergency, the City's prepared emergency operation plan includes the use of the library as an emergency operation center (EOC). Some library employees have been moved over to the emergency management primary employee list to keep building open 24/7. A secondary EOC location has been established so that when the Governor's Executive Order restrictions are lifted before the emergency disaster is concluded the City will move from an operations plan to recovery plan, which can last 18 months. The second EOC is presently being used as a decontamination site for our first responders and EMT.

#### Councilwoman Wooten reported the following:

The City of Orange Township's 2020 Census response is at 39.5%.

The State of New Jersey's 2020 Census response as a whole is at 58.6%.

Outreach resources are being implemented, which includes contacting buildings and placing posters and St. Matthews Church is helping.

The Legal Help Desk has assisted over 120 callers with evictions, tenant and unemployment problems and executive orders. You can reach the Legal Help Desk can be reached at (973) 640-3526.

In regards to Governor Murphy's Executive Order regarding renters, a landlord can use a tenant's security deposit for rent, but must be paid back.

The 90 days grace period only applies to unemployed tenants who have no source of income and are waiting for unemployment benefits.
