MATTERS FOR DISCUSSION: Update on COVID-19.

Business Administrator Hartwyk provided an update on COVID-19:

- As of April 7, 2020 at 2:00 pm. there are 5,042 confirmed cases in Essex County; 41,265 in the State of New Jersey; 214 deaths in Essex County and the City of Orange Township has 249 reported cases.
- All public buildings, parks, and non-essential businesses are closed.
- The City has partnered with East Orange, Irvington and Newark for boarder control to enforce the 8:00 p.m. curfew.
- The City is providing food distribution for senior citizens or a family with children in need of food assistance. They are encouraged to call (973) 280-1621 or visit the website www.ci.orange.nj.us and submit a request form.

- Resolutions 400-2019, 40-2020, 144-2020 and 145-2020.


Motion to adjourn the meeting by Councilman Coley, seconded by Councilman Jackson.
