Ordinance on Second Reading 23-2020 Establishing Citizens Oversight Committee for Police Department

Hoping all is well. I would like make a statement regarding the CCRB being established in the City of Orange. I would like my statement to go on the record and wish to say it myself if possible at the meeting. I do not wish to give my address, but I can be reached via cellphone and/or email.

I vote the CCRB be adapted into the City of Orange because I think it will forester a positive communication between the OPD, residents, and business owners. This board encourages members of the community to file complaints when they feel like they have been victims of police misconduct, giving both parties the opportunity to mediate and promote understanding.

We may think this Committee isn't needed because we're a small community, but it's needed to reinsure transparency, fairness and clear line of communication between city officials and the community.

JODY LEIGHT

I wish to submit comments of proposed Ordinance 23-2020, which is coming up for a second reading at tomorrow's meeting.

It is commendable that the Council is taking action n to increase transparency and to create a

neutral forum where members of the public can feel safe reporting any issues concerning alleged police misconduct. This can only serve to improve community-police relations and improve public safety overall.

However, certain aspects of the ordinance as drafted raise potential legal issues, and the public interest might best be served by having this reviewed by counsel before taking action.

One issue is having the Police Director sit on a Civilian Review Board, and having specific duties related to audits of his department. This is not in any way meant as criticism of the current Director. Nevertheless, having the Director sit on a Civilian board could create the appearance that the Review Board is not independent, which would compromise its ability to function. Also, having authority regarding audits of the Director's own Department can be construed as a conflict of interest.

I am also concerned about lack of clarity in the sections relating to appointment of other members. I am personally familiar with two of the organizations listed, The University of Orange and the HUUB. I drafted the University of Orange's 501(c)(3) application, and have participated in activities sponsored by that organization and the HUUB. The latter organization is a program affiliated with the First Unitarian Universalist Church of Essex County, where my husband served as minister for nine years. Both organizations do good work and contribute substantially to the Orange Community. But it is not at all clear that the requirements for being a "member in good standing," to the extent they can be determined, have any bearing on qualification to serve on a Civilian Review Board. Too, while I have nothing but the highest esteem for First UU (as a lifelong Unitarian-Universalist and a clergy spouse), I must note that creating the appearance of favoring one particular church or denomination raises possible I First Amendment issues regarding separation of church and state.

Finally, a drafted, the ordinance appears to designate as organizations responsible for designating Review Board member's entities or categories that are not in fact organizations.

The creation of a Civilian Review Board is an important action. The enabling legislation deserves more careful drafting.

The legislation's faults include the inclusion of the police director on the board and insufficiently clarity about stakeholder groups as a source of members or nomination of members. This legislation needs to be deferred to a time when a full public discussion of its merits can be held.

As a tax-paying citizen in the Township of Orange New Jersey, please acknowledge and reply to our community's collective concerns in regard to our town's safety and the exorbitant budget. **I urge the city and city council to consider either a 0% increase in our budget or a reduction of taxes**. Instead of increasing the budget, please reprogram and find ways to work within the current budget numbers like many of us have had to do this year (including the school district and schools that I work for).

Last year, there was a large tax increase that caused myself and many of our neighbors to either refinance or make serious cuts. Due to COVID, my current company is not giving anyone a raise and many of my neighbors are in the same position or out of work. We must find ways to eliminate excess spending.

Below are our questions:

Township Traffic / Speeding / Signage

- a) Regarding the Flashing lights on Heywood Ave. & Mosswood Ave: in order to curb the issue with speeding, we suggest that the Township make the lights RED at all sides in order to create a 4-way stop. (e.g. Similar to South Orange at the intersection of Montrose Ave & Vose Ave). If the speeding persists, we should move to replace the lights with physical 4-way stop signs. Is this possible, and if not why?
- b) Regarding the speeding on Heywood Ave: in order to create safety around the Heywood Ave Elementary school, we have long suggested there be an officer placed at the top of the hill on Berkley Ave & Heywood Ave just as there is one at the intersection of Scotland Ave & Heywood Ave. That would curb the speeding and frequent U-turns that make it unsafe to drop off/ retrieve children. When can we make this possible?
- c) We suggest a formal letter be sent to the Berkley Tennis Club Association (located on 311 Tremont Place) to address the members speeding on one side of the street in order to enter the facility. Would this be the proper protocol, and if not, what would you suggest?

- d) Can the Council also address the lack of proper soil retention of the clay courts at the Berkley Tennis Club Association (located on 311 Tremont Place). (e.g. when it rains the streets become red with clay that is not properly retained.)
- e) We suggest that there be adequate speed signage on Heywood Ave (btw Center Street & Berkley Ave) to reinforce the speed limit. We are aware that there are funds budgeted for city signage so when will this aforementioned issue be addressed?

Township Budget from the Mayors Recommended Budget Calendar 2020

- I. Can the council or Department of Administration provide the Citizens of Orange transparency concerning the written Regulations for the Towns "reprogramming" the budget line items?
- i) What is the approval process for reprogramming each budget line item? (e.g. can 1k be moved without an administrative approval)
- ii) Are there metrics available for who does the oversight of the Townships reprogramming? By Whom? Who does the reprogramming the most? Which Department request the most reprogrammed funds?
- a) Can there be more clarification on the library's requested budget increase (e.g. 100k for books, magazines, and CDs)? Instead of having just a hard \$ amount, there should also be an amount column showing how many items were purchased / \$ amount.
- b) Can the council please explain and provide details surrounding the line item of \$946,000.00 for Maintenance of Free Public Library? How will this money be allocated? We are aware that the government gave a 2.5-million-dollar grant to the Library for Hurricane Sandy relief. We have yet to see that money at work, so we are concerned that you are asking for an additional \$1,370,19.72 (total Library Budget, not including the 2.5 million grant). How does this new budget reflect the effects of the COVID-19 pandemic?
- c) Please explain the "Other expenses" category for the Business Administrator's office budget of \$780.00. What is are the "others"?
- d) Can the council please explain the 20% increase to the police budget? Due to the impact of COVID, how can we justify an increase in hiring and salary? We have noticed that multiple departments have requested more funds for salaries and wages. Conversely, many residents of Orange have been furloughed, laid off and/or had their wages frozen. Why can't our township follow our Mayor's instruction to "Do more with less"?
- e) Can the council please further explain the \$2,680,000.00 for the Police Department- salaries and Wages- CAP Waiver?
- f) Can the council please provide a report, which was requested by the previous Council President during a budget meeting, on the achievements (e.g. jobs provided or have been filled and how many have been helped) by the Community Service Aide/ Re-Entry Coordinator that was employed 4 months ago with a salary of \$75,000.00? This position was not publicly posted, as legally required, but was appointed by the Mayor. The citizens agree with the previous Council President, that providing a report would help us understand the efficacy of this added cost.
- g) There was a mentioned plan to move civilian duties, including positions such as crossing guards, out of the police department's budget. Civilian duties should be a separate department in order to lend transparency to the operating costs of the police department. Will this be done?
- h) Can the council please explain why is there a \$450,000.00 request for Fleet management under the Department of Fire? This request should be FROZEN, due to our current health & financial crisis.

- i) Can the council please explain why the Emergency Authorization for the Ian Betz case at the sum of \$1,510,000.00 is the town taxpayer's responsibility?
- j) Can the council please explain what is the Emergency Authorization for Health Benefits at the sum of \$300,000.00 and what is the purpose of it?
- k) Can the council please explain why under the Department of Community Services there was a salary increase while personnel who are slated for retirement has not left and is still collecting wages?
- 1) Can the council please explain why under Recreation: there is an increase in salary and headcount, but no increase in programming. Please explain how this is possible.
- m) With energy usage being down, can the council please justify the increase in energy cost at \$440,000.00?
- n) Can the council please explain why under Loan payments for Principal and Interest (Listed as Debt Services for the City listed at \$2,242,939.00); What is the remaining balance on all the bonds listed and when do they end?

Community questions regarding the South Ward

- a) Regarding the Easement in between Haxtun Ave and Mosswood Ave. We suggest there be official city signs for the private easement. (An easement is defined as a right to cross or otherwise use someone else's land for a specified purpose.)
- b) Is the aforementioned easement, Does the city regard this space as public or private? Also, where does the responsibility for maintenance lay?
- c) Concerning home flipping construction projects: the city needs to provide more oversight, through Planning / Historic Commission. Additionally, there is non-permitted work occurring during non-permitted hours and there are changes being done to many homes character and landscaping without regard to existing ordinances.
- d) Current Tax appeals have not been processed due to Covid-19 shutdowns. Please provide guidance to the citizens how are currently seeking an appeal.
- e) As per the 2018 Master Plan the Historic Commission has the power to provide a Historic district tax abatement for landmarks and districts (2018 Master Plan-pg165), how does the council plan to move forward with providing the commission with the power and authority to execute these abatements?

Community questions regarding Noise / Crime

Why has the 10 pm city ordinance not been properly enforced? There are at least two properties on the corner of Heywood and South Center Street that have consistently been a source of violations. Since these issues have remained unresolved for years, it has become an unsafe situation. I have personally shown up at public meetings and have expressed the problem to multiple council members. There needs to be a more vigilant approach to enforce 10 pm curfew. When I have attempted to rectify the situation, but it has not ceased. In the process, I have been called multiple derogatory epithets and contacted the police to no avail.

737 South Center Street - July 5th - I called the police station at 10 pm - spoke to a supervisor - as this went on well past midnight still no one had come to shut it down

General community questions

a) Is there a way to increase library access through programming and community outreach? Further, do we track library utilization and measure which services are being most frequently used?

- b) Can the council please advise which Ward generates the most revenue for the township? And why is it that not reflected in the services that the respective ward's receives (e.g. road paving, signage, recreational options etc.)
- c) For the Police Department: we are requesting an immediate decrease and for funds to be allocated to early intervention programs. Black Lives should also matter in the Township of Orange.
- d) We suggest the council looks into mandating home flippers / Real-estate investors to pass along tax abatements to the new homeowners to aide in the unforeseen property tax increase.
