Subject: Proprietary Vendor Affirmation for ABC Emergency Leasing

I, Kenneth M. Douglas, Fire Director for the City of Orange Township, in Essex, New Jersey, affirm that:

On December 7, 2019, Engine 2 was involved in an accident that caused severe mechanical and frame damage resulting in it being inoperable to respond to fires and emergencies which negatively affects emergency response and community safety.

For this reason, an extensive search was conducted through the internet, public safety partners and neighboring cities in an effort to rent or lease a fire apparatus for firefighting duties.

As a result of this search, it has been concluded that ABC Emergency Leasing is the only entity in the North East region offering the use of front-line fire apparatus for the use of firefighting.

At this time, there is no foreseeable time frame that Engine 2 will be repaired.
