LOCAL AID GRANT AGREEMENT

City of Orange with offices at 29	North Day Street, Oran	nge, NJ 07050 (hereinafter
referred to as Orange).		

WHEREAS, the County has awarded Orange a \$150,000.00 grant to fund the Colgate Park Pool Improvement Project (hereinafter referred to as "the Project");

NOW, THEREFORE THE PARTIES DO HEREBY AGREE AS FOLLOWS:

- 1. Orange will complete the project by or before September 1, 2021. The County, at its sole discretion can extend this completion deadline.
- 2. Grant award funding will be provided to **Orange** upon the submittal to the County of a certified municipal resolution voted upon by a majority of the **Orange** governing body authorizing the successful vendor and/or bidder to proceed and complete the project or phases thereof.
- 3. Each site that receives funding must erect a sign measuring at least 2' x 3' and contain at minimum the following:

- 4. The funds shall be used solely and exclusively for the construction of the Colgate Park Pool Improvement Project.
- 5. Orange shall procure or cause its designated agent to procure contractors/professionals to design and construct the Project in accordance with N.J.S.A. 40A:11-1, et seq., (Local Public Contracts Law) and the rules and regulations adopted pursuant thereto.

- 6. Orange and/or its designated agent shall comply with all federal and state laws, rules and regulations and, if applicable, all Green Acres Program requirements for the project.
- 7. Orange and/or its designated agent shall be solely responsible for the design, construction, maintenance, operation and repair of the project. The County shall have no responsibility for the design, construction, maintenance, operation and/or repair of the Project.
- 8. In the event that any portion of the grant or matching funds remain at the completion of the above mentioned project, those funds will be used for improvements of the project consistent with **Orange's** initial application to the Open Space Trust for funds and subject to County approval.
- 9. Orange assumes all risk and responsibility for and hereby agrees to indemnify, defend and hold harmless the County of Essex and its agents, officials and employees from and against any and all damages, claims, demands, liability, judgments, losses, expenses, or costs arising or claimed to arise from acts of omissions during design, construction, maintenance, post-construction operation and/or repair of the Project of Orange its officials, employees, agents, contractors or subcontractors.

Orange shall also, at its own expense, appear, defend and pay all reasonable charges for attorney's fees and all reasonable costs and other expenses arising from and incurred in connection with such claims.

Orange shall within twenty-four hours of its receipt of any notice of claim, or notice of injury of any type, immediately notify the Office of Essex County Counsel of any notice of claim.

Orange's duty to indemnify, defend and hold harmless the County shall continue after the termination or expiration of this Agreement.

Orange shall include, or cause to be included a provision in all contracts executed for the purpose of carrying out the project a requirement that the contractors and subcontractors provide the County with indemnification, defense and hold harmless protection at least as broad as set forth above. Further, the County shall be named as an Additional Insured under all contracts of insurance for the Project whether held by Orange or contractors and subcontractors.

10. In the event **Orange** does not comply with this Local Aid Grant Agreement, the County, without waiving any other actions at law or equity, may take any of the following actions: a) issue written notice of noncompliance and directing corrective action in 30 days; b) if corrective action is not taken or cannot be taken for whatever reason, require **Orange** within thirty (30) days of notice to repay the full amount of all Open Space Trust funds paid hereto **Orange** agrees to make this payment even

if it objects to or disagrees with the County regarding the need for corrective action and/or the ability to take corrective action. Nothing contained herein shall act as a waiver of **Orange**'s rights at law or in equity regarding the repayment.

- 11. The County may terminate this Agreement, at any time, if any representations or warranties made herein or in any certifications, reports, plans, financial statements or other information furnished by **Orange** in connection with this Agreement shall prove to be knowingly or intentionally and materially false or misleading. Within thirty (30) days of notice by the County, **Orange** shall repay the full amount of all Open Space Trust Funds paid hereto. **Orange** agrees to make this payment even if it objects to or disagrees with the County. Nothing contained herein shall act as a waiver of **Orange's** rights at law or in equity regarding the termination or repayment.
- Orange may rescind this project agreement at any time prior to acceptance of any Open Space Trust funds. Orange may not terminate this agreement after accepting Open Space Trust funds without written approval from the County and without repayment in full of all Open Space Trust Funds paid hereto.
- 13. This Local Aid Grant Agreement constitutes the entire agreement and supersedes all prior agreements and understandings. Neither party shall rely on any verbal or oral representations.
- 14. This Agreement shall remain in effect until the completion of the Project. However, **Orange's** obligations under paragraphs 8, 10 & 11 of this Agreement shall continue after completion of the Project and termination of this Agreement.
- 15. This Agreement shall not be assigned.
- 16. This Agreement shall be construed and enforced under the laws of the State of New Jersey.

Internally, the pool needs an updated filtration system, as it not maintaining the chlorine levels needed to be safe for swimming. Skimmers in the pool need to be reconstructed as they were not adequately fixed and are needed to drain the pool. The other drainage needs are new grates, as they expire every few years.

Along with internal and external physical improvements, the pool needs to install one handicap assessable chair lift and multiple safety ladders at points of entry. The depth markers and official signage needs to be updated as they have become unreadable and weathered.

2. Describe compatibility with adjoining land uses.

Colgate Park falls in between North Center Street and North Day Street in downtown Orange Township. The Park contains multiple recreational facilities in addition to the Colgate Park Pool. The park has two full-size basketball courts, two play areas for small children, and a large picnic area in-between. The City of Orange has also proposed converting a large open space towards the right side of the park into a skate park. This project has not been approved yet, but is a top priority for the City. Although the park is popular and important to the community, the pool specifically has been overused and proposes a health and safety risk to members of the public who utilize this space.

The park is surrounded by mostly single-family residential housing. The area is home to small businesses like bodegas, restaurants, and some government buildings.

3. Identify historic/cultural features on the site, if any.

The Colgate Playground is on the ROSI and has historic significance as it was donated by Richard Colgate, the founder of Colgate Company.

The reconstruction of the Colgate Park Pool will serve to reinvigorate the community's love for swimming during the hot summer months. As a result of this project, the city will gain a new platform to showcase its effort to invest in the City's open spaces and parks. Yet, the focus of this project is the bring the city's pool into compliance with ADA standards and improve the water filtration system along with other physical improvements to the Colgate Park Pool.

This pool serves as one of the three public pools in the City of Orange. The pool is not only used by the general public, but used by the many summer camps and recreational programs in the community. Since Orange is a densely populated and majority low income community, public
