TITLE: A RESOLUTION AUTHORIZING THE ORANGE CHAMBER OF COMMERCE, DIVISION OF MERCHANTS TO CONDUCT SIDEWALK SALES IN THE CITY OF ORANGE TOWNSHIP, NEW JERSEY ON JULY 16TH, 17TH, 18TH, AUGUST 13TH, 14TH, 15TH, SEPTEMBER 17TH, 18TH, 19TH (RAIN DATES: JULY 25TH, AUGUST 22ND, AND SEPTEMBER 26TH, 2020).

WHEREAS, the Orange Chamber of Commerce, Division of Merchants has made an application to the Division of Licensing to conduct a Sidewalk Sale in the City of Orange Township on July 16th, 17th, 18th, August 13th, 14th, 15th, September 17th, 18th, 19th (rain dates – July 25th, August 22nd, and September 26th, 2020); and

WHEREAS, Robert Masoud, President of the Orange Chamber of Commerce, has completed the required application (a copy of which is attached) to conduct sidewalk sales on Main Street and the intersecting streets thereof; and

WHEREAS, Robert Masoud has duly signed a letter that the sidewalk areas used for the sidewalk sales will be restored to their proper appearance no later than one day after the conclusion of the sales; and

WHEREAS, after consideration of the aforesaid application and the letter signed by Robert Masoud that the merchants will comply with all the requirements of Chapter 105 of the City Code of the City of Orange Township, the City Council authorizes the sidewalk sales for the benefit of the community.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Orange Township that, after consideration of the application of Orange Chamber of Commerce, Division of Merchants and the letter signed by Robert Masoud that the merchants will comply with all the requirements of Chapter 105 of the City Code of the City of Orange Township, the City Council be and hereby authorizes the sidewalk sales for the benefit of the community.

BE IT FURTHER RESOLVED that the proper officers of the City of Orange Township be and are hereby informed that said application has been approved as permitted under Chapter 105 of the City Code.
