Gerald Lloyd representing his father, the owner of the property on 664 Valley Street, Orange, New Jersey, received two summons. The former regarding exterior work done without a permit and the latter for not coming before the HPC prior to completing exterior work. Mr. Lloyd expresses that without renovations to the drive way he would be unable to obtain a FHA loan, that he was ill informed by the construction officials, and that he attempted to preserve the historic architecture of the house.

Commissioner Janice Morrell offered options to the HPC: could do nothing, deny the application for appropriateness, or approve the work.

Commissioners agreed it was unnecessary to undo the work, but a fine would be issued.
