#### **NEW BUSINESS**

A. Certificate of Appropriateness Application – 572 Nassau Street, Orange, N.J. (removing the existing damaged siding and replace with brick face to the entire front of the house and siding on the sides of the house)

Applicant Rafael Macdonal appeared with his wife, Jacqueline Macdonal, who was his interpreter. Ms. Macdonal testified that they want to remove all of the existing siding and replace it with front brick face and siding on sides and top half of the front of the house.

There was a discussion between the Commissioners and the Applicant regarding preserving the original materials and the proposed materials to be used, as well as, the condition of the home under the siding. Applicant advised that although the siding is damaged he has not removed same to see what is under it. In addition, the roof is leaking; therefore, water is coming into the house.

The Commission requested that the Applicant mend the leaky roof and remove the siding on several spots of the home. Thereafter, the Technical Review Committee will go out to the home, make an assessment and report back its findings to Attorney Bauer. The Commission will make a decision once the findings are returned and requested the application be rescheduled to the September 18, 2019 meeting.
