A resolution authorizing the purchase and installation of playground equipment to Whirl Construction, Inc., 194 Main Street, P.O. Box 110, Port Monmouth, New Jersey 07758 for the Central Playground Improvements Project under the Educational Services Commission of New Jersey (ESCNJ) Co-Op Contract #20/21-02 in an amount not to exceed \$84,508.00.

Councilwoman Summers-Johnson expressed her concern that the equipment ordered does not have a handicap accessible swing and the re-ordering of stainless steel slide which becomes extremely hot during summer days.

Director Mayes reported that the existing swings are 25 years old and he had opted for the stainless steel slide since it will be durable, longer lasting and avoids cigarette burns. Moreover, Director Mayes informed the Council that if they prefer a plastic slide the change can be made.

Councilwoman Wooten inquired about the safety surface equipment.

Director Mayes reported the City is replacing all of the rubberized surfacing for all of the play areas.

Business Administrator Hartwyk reported that the City will add the handicap swing to the project.

Director Mayes reported that the park equipment's life expectancy is over 20 years.

Councilman Ross inquired when the work will be completed.

Director Mayes reported the in a matter of weeks after presenting the adopted Resolution to the County.

Councilman Montague inquired about the damaged chin-up bar and its liability to the City.

Director Mayes reported that this project is being financed by the \$140,000 approved in 2019 earmarked for Colgate Park and another \$140,000 has been approved for 2020. The City will have to decide on how to spend the funds for the Colgate Park and the location of the chin-up bar can be decided.
