Mike McKeon, Vice President of M&T Bank testified that M & T Bank is changing its logo and appearance of its signage for aesthetic reasons and that the existing signage needs to be replaced, together with parking plaques, and door signage for that reason. that they want to reface and refurbish the sign since they have modified their logo.
