## **MATTERS FOR DISCUSSION**

Council Vice President Eason introduced Christopher Durkin, Essex County Clerk to discuss the November 3, 2020 General Election. The following topics were discussed:

**#2020 CENSUS** 

- Due to the Pandemic, the General Election will be primarily a Vote by Mail election.
- As of October 20, 2020, the County Clerk's Office has mailed out 17,500 mail in ballots to City of Orange residents and has received 4,190 back.
- No electronic voting machines will be available at the polling places.
- Residents can go to the polling places to either drop off their mail in ballots or fill out a provisional ballot.
- Disabled residents will be allowed to vote by an audio component hand held device.
- Encouraged residents to use the secured ballot drop box to return their ballots in any of the 25 secured ballot drop boxes in Essex County.
- Provided a detailed description on how to fill out and return a mail in ballot.
