This event has highlighted inadequacies that must be addressed. We did receive the new Fire Department numbers in an email early this morning. We need to move swiftly to update all numbers and voicemail boxes in all city departments to better serve the community.

A busy signal, full / un-setup voicemails and apathetic first-responders are never what a person in need should receive.

# **Design Standards**

At the planning meeting on November 30, 2020, the developer seeking to demolish 3 single family homes on Highland Avenue was approved to build 140-Units in conflict with the valid concerns of the public.

Res 476-2020 - If I have understood the resolution correctly, we owe \$7,613,102.17 to Suez. Does this amount include the monies listed in Resolution 469? The resolution stated the City of Orange Township is disputing additional monies listed in the remaining balance. How much money remains in the balance? Who monitors the invoices to ensure that the municipality does not receive bills listing markups and overcharges?

Ms. Janice L. Morrell commented live had the following comments:

At the end of the past successive years, it appears that we owe monies to Suez. Does structural deficit exist relative to our agreement/contract with Suez? Does the administration need to renegotiate the contract? Has COVID resulted in more spending for the City? If so, how much.

Motion to close Citizen Comments by Council Vice President Eason, second by Councilman Johnson, Jr. The Motion was unanimously approved.

Business Administrator Hartwyk reported the following regarding the walk-on resolutions:

- In regards to the \$300,000 shortfall in group health line:
  - The City's group health program is a self-insured.
  - The City estimates it budget from the prior year expenditures.
  - At the end of 2019 and into 2020, there was a catastrophic loss resulting in the City owing \$300,000 for one claim.
  - The City was not aware of the gravity of the matter when it budgeted for 2020.
- Transfer of Appropriations:
  - Adjustments at the end of the year to settle cases are not uncommon.
  - Adjustments have been made in prior years for settlements and judgments.
- Bill list and Suez Resolutions:
  - Only \$1.2M of the \$7.6M actually had to come before the Council since the other amount was previously approved.
  - The whole \$7.6M was brought before the Council for transparency.
  - Held payment for Suez bills and questioned markups for emergency work and capital improvements.
  - The markups were 15% on labor and materials.
  - Markup did not show up on 2019 bills.
  - An audit of the all 2019 and 2020 Suez bills was done.
  - Contract only allows for markups on materials but not labor.
  - Audit revealed a double payment of \$938,000.
  - The City was able to reduce the amount owed by over \$2M.
  - The \$1.2M is for work paid from the operating budget though the capital maintenance line.
  - The \$1.8M is for reduction in revenue resulting from the Governor's Executive Order that took away all enforcement of water and sewer bills.
  - Repayment of \$1.8M does not start until 2022 and the City has 5 years to pay.
  - Anticipates the City will be able to pay \$1.8M within 2 years.
  - Last 2 years, the City did not owe Suez any money at the end of the year.
  - Department of Administration is preparing a RFP for the operating and maintenance agreement.
  - Contract with Suez does not expire until the end of 2021.
