ORDINANCES-INTRODUCTION/FIRST READING:

- 47-2020 Amending and supplementing Chapter 88 "Fees" Department of Planning and Development and Zoning Information Request Fees CH confirmed that old fee of \$25.00 did not cover time needed to process zoning application; increase to \$100.00. CR asked how much other towns charge; CH confirmed some charge as far as \$250.00. TB asked about how many applications are processed in a year. CH confirmed that it is more than 1,000. Move forward.
- **48-2020** Repealing Chapter 210, "Development Regulations" CH explained in order to create new Zoning ordinance, the old one has to be repealed. Move forward.
- **49-2020** Amending Chapter 4 in include provisions governing remote public meetings during declared periods of emergency. TE suggested that this be voted down as this amendment needed to be a resolution, in which Resolution 403-2020 resolves.

RESOLUTIONS

- *386-2020 Amending Resolution 21-2020(WO) seeking to authorize additional attorney fees CH confirmed that this resolution is for the Legislative Research Officer's contract salary. TB asked reason for increase. JL confirmed that the Officer attends all meetings and provides additional research, causing uptick in amount of work performed. Move forward.
- *387-2020 Authorizing a refund of sewer payments made on 13 Lafayette Street for \$5,019.60 Move forward
- *388-2020 Authorizing a refund for overpayment of water/sewer charge for 205 South Jefferson Street for \$21,610.63 – Move forward
- *389-2020 Authorizing the purchase of mini bus for the Department of Community Services CH confirmed that bus is handicapped accessible. CH also confirmed that these vehicles are not covered by the Fleet Management Program. CR asked for list of grants that the City has applied for. JL confirmed that monthly list was included in prior agenda package but will resend to all Members. Move forward
- *390-2020 Directing Ordinance 40-2020 take effect immediately Move forward.
- *391-2020 Amending Resolution 283-2020 seeking to extend contract with ABC Emergency Rental Move forward
- *392-2020 Rejecting bid for Public Works Yard Facility and Site Improvements TE asked if this will be re-bid; CH confirmed that it will. Received bids were too high and City believes it can get better pricing by re-bidding. Move forward
- *393-2020 Authorizing the award of contract with Bright View Engineering LLC to provide parking study – CH confirmed that parking issues in City and in upcoming projects. Rewrite of parking regulations by zone is needed. TE confirmed that this is sorely needed in the City. Move forward

*394-2020 Authorizing refund of funds in escrow account for City off duty police – Move forward

- *395-2020 Authorizing the services of David C. Stanziale, LLC to represent Chris Hartwyk –CH confirmed that there an issue with a former police officer that caused disciplinary action and a federal investigation against the employee. After speaking with the employee and resolving the matter, the employee's attorney advised that because Mr. Hartwyk has a law degree, he was unauthorized to speak with employee regarding the matter, causing an ethics complaint against Mr. Hartwyk. Since this was within his job scope and not in a representative manner, Stanziale, LLC will represent him. TB asked if ruling is in Mr. Hartwyk's favor, can the City be reimbursed the attorney fees. CH confirmed that if he gets a favorable ruling, a deformation suit and action to recover costs will follow. Move forward
- ***396-2020** Authorizing the agreement between the City and the RPM Entities CH explained that this is a settlement agreement with City and RPM for unpaid land taxes. Move forward
- *397-2020 Authorizing the contract with Bright View Engineering LLC to provide engineering design services for Main Street Streetscape & Traffic Control Project CP II asked about the rules of Non-fair & Open vs. Fair & Open. AP explained how RFQs work; once list is comprised, anyone can be chosen from list, not based on price. The Non-fair process does not have to go out for RFQ or RFP, but certain forms have to be completed.
- *398-2020 Stating that the City supports Bills ACR 145 and SR 96– Move forward
- *399-2020 Celebrating the life of Nena Carolyn Hamm Move forward
- *400-2020 Recognizing October 10, 2020 as World Mental Health Day Move forward
- *401-2020 Authorizing request for legal counsel to investigate and advise City on potential legal claims against Jeffery Feld VP explained that Mr. Feld has a number of lawsuits. Due to amount, seeking special counsel to investigate possible action the City can take against him. JL asked AM why resolution was needed to authorize RFQ. AM explained resolution is needed to establish list of counsel once responses received. TB asked how many lawsuits Mr. Feld has against the City. CH confirmed it is over 20. JL asked about possible conflict of interest since she reports to the Council and is also in litigation with Mr. Feld, not being represented by City Attorney. CH confirmed that it should not impact her case. JL will have off-line conversation with Law. CR asked since Mr. Feld is not a resident nor business owner in Orange anymore, can the City handle him differently. VP confirmed that anyone can ask questions or request OPRAs. More legal research will be needed to confirm if additional action can be taken to protect the City against his claims.

- *403-2020 Rescinding Resolutions 180-2020(WO) and 297-2020 and adopting a policy in accordance with the LFN 2020-21– Move forward
- *404-2020 Authorizing amnesty to waive interest for property taxes, water and sewer charges from October 6, 2020 through November 6, 2020 Move forward

*405-2020	Approving the bill list (Grand Total: \$5,533,427.22) – CP II advises that we should be mindful of overtime and find ways to reduce it. Move forward.
*406-2020	Confirming re-appointment of Rashida N. Hasan as Judge for three-year term – Move forward
*407-2020	Awarding contract for cloud hosting servers, backup maintenance, management and technical support to Sysnet Solution for two years– Move forward
*408-2020	Appointing Murphy Wilson as Citizen Member of Policy and Planning Committee – Move forward
*409-2020	Designating B&O Urban Renewal, LLC as redeveloper for properties included in the Transit Village District East portion of the Central Orange Redevelopment projects –Move forward
