INSTRUCTIONS TO SIGNERS AND CANDIDATES

This petition must be filed with the City Clerk, City Hall, City of Orange Township, at least sixty-four (64) days before the date of the primary election. (N.J.S.A. 19:23-14)

The petition must be signed by at least 5% in number of the total vote cast by the voters of that political party at the last preceding primary election held for the election of that party's candidates for the General Assembly who reside and are registered to vote in the said district. In no case, however, shall there be fewer than one signer of any such petition. (N.J.S.A. 19:23-8) The petition may be signed by a greater number of voters than are necessary. Each person must sign his or her name in the presence of the person who will certify thereto. A voter may sign only one petition.

The candidate must be a member of the Democratic Party, and resident in the district.
