Each person addressing the Commission shall give his or her name and address in an audible tone for the record, and unless further time is granted by the presiding officer shall limit his or her address to five (5) minutes unless the comments are repetitive of other witnesses in which case the presiding officer may further limit the comment period.

NEW BUSINESS

A. Certificate of Appropriateness Application – 540 Forest Street, Orange, N.J. (Installation of roof mounted solar systems) (Rescheduled from the 10/21/2020 Meeting)

Mr. Leonard Stewart testified that he would like to have solar panels installed on the roof of his home. Ms. Angela Chakov from Solar Vision also testified that the solar panels will be installed on the right side of the roof and would not be visible from the street.

Attorney Bauer questioned the layout of the solar panels per drawings submitted and its visibility from the street.

The HPC requested that plans be reconfigured and the first four panels moved to the back of the home. Ms. Chakov further testified that she will have the design team work on the reconfiguration.

B. Certificate of Appropriateness Application – 390 Heywood Avenue, Orange, N.J. (new exterior siding, roofing and windows)

Unfortunately, the window plans submitted do not match the character of the house. The windows should be divided light windows.

Lastly, the HPC has requested that the applicant's application be rescheduled to the next meeting and a revised scope of work be submitted.
