9) Joanne Douds, 697 Valley Street, Maplewood, NJ 07040 - Ordinance 14-2021 I am a South Orange resident and am writing out of personal experience regarding members of my family. I am clear that a cannabis business in responsible hands is a must in health care today.

I had an 83 year old Republican, Swedish father, that three days before he passed from lung cancer, made me promise to help legalize the use of cannabis for medical reasons. He said it was what got him through his cancer treatments. That was shocking to me and these were amongst his final words.

We also have a 30 year old son with juvenile diabetes (Type 1 - pancreas dead, insulin dependent) Whose doctor has him use CBD and cannabis to control his blood sugar. He is vigilant in controlling daily. He is a tri-athlete and is a pioneer in the world for the Type 1 Diabetic Community. You can see his amazing work on YouTube ErikDouds and his company is Diabadass.com. He is an excellent speaker and has spoken around the world. He has also been published in many world publications. You may want to invite him to speak.

Orange is a community emerging to great new places. I strongly believe in Orange and the planning of its great future with the Valley Arts Business Council. Additionally, Maplewood has a small CBD shop recently opened next to Perch Home. You may want to speak with the Mayor of Maplewood.

Here's to progressive care for those who benefit from the use of cannabis. I may not have my son living a powerful and healthy life without this substance. With gratitude for your consideration.

Joshua Uhl, 540B Freeman Street, Orange, NJ 07050 Ordinance 14-2021- Cannabis Businesses 10) As a business owner in Orange, I'm writing today to ask you to reconsider if you support Ordinance 14-2021. I think the decision to eliminate Cannabis Businesses from Orange is a tragic mistake. In my opinion Cannabis-based businesses have a very legitimate place in our community. I think the fearmongering surrounding cannabis-based business is just a further perpetuation of our country's failed "War on Drugs", a racist policy by design that has disproportionately incarcerated people of color, tearing their families apart.
