Vincent DeFilippo, City of Orange's Health Officer discussed the following update regarding COVID-19:

- St. Matthews Church has administered 1,800 doses in its first week.
- To date, 2,596 Orange residents have been vaccinated with the Moderna vaccine and 273 Orange residents have been vaccinated with the Johnson & Johnson vaccine.
- The average positive cases in Essex County are 30 to 49 years old.
- St. Matthews Church will be administering the second dose starting April 21st from 8 a.m. to 5 p.m. You can make an appointment by calling (862) 236-0946.
- Transportation is available to the Stephen Adubato Center by calling (201) 563-2346.
- Three (3) new strains of COVID-19 has been confirmed in New Jersey.
- There are four (4) Ebola cases confirmed in New Jersey.
- On Wednesday, April 21st the Summit Medical Group will be at the Lincoln Avenue Food Pantry from 9:00 a.m. to 12:00 p.m. for blood pressure and glucose screening.
- Churches of the Oranges located at 271 Reynold Terrace will be administering the Pfizer vaccine on April 29th and 30th and May 1st.
