For the past 5 years The HUUB, Inc. has worked to enhance the quality of life for residents of Orange and the surrounding area by making our campus available to the community and providing programming in the arts, education and community development. We are a leader in disseminating information about protection from the spread of COVID 19 and keeping citizens informed about city policies that affect their lives. Our model for community engagement is Asset Based Community Development which calls

us to build upon the strengths that already exist in the people and institutions of our community. We are therefore in favor of safe and regulated business opportunities that bring revenue into the city and help entrepreneurial citizens to realize their potential.

On November 3, 2020, residents of the City of Orange Township voted overwhelmingly in favor of Public Question # 1. On February 22, 2021, P.L. 2021, c. 16, was signed into law by Governor Murphy. It allows for the recreational use of marijuana for adults 21 years of age and older and requires that each municipality develop regulations concerning the location, type and number of cannabis businesses in the community, hours of operation, consumption areas within a business and regular inspections for compliance.

Two (2) parts of this legislation make it particularly appealing to Orange residents AND to the City of Orange Township:

#### **REGULATIONS AND REVENUE:**

Regulations adopted and enforced by both the municipality and the state minimize the risk of any harm to the community and make this emerging industry safe and beneficial to consumers.

Unlike most other taxes imposed on businesses in New Jersey, the Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act provides for a 2% sales tax on retailers, cultivators and manufacturers and a 1% sales tax on wholesalers paid directly to the municipality.

Revenue from a regulated cannabis industry in Orange can off-set the cost for services and reduce the tax burden on residents: Improving recreation programs and their facilities, building a new library, creating job training programs, improving services and facilities for seniors are all possible with this new emerging revenue source. To take a "wait and see" approach means a missed opportunity as other municipalities in the area will very quickly fill the void and be able to serve the needs of Orange residents.

The HUUB, Inc. urges every member of the City Council to VOTE AGAINST ORDINANCE NO. 14-2021 and support a bright future for the City of Orange Township!

Banning Cannabis business in Orange will be a loss against the legalization of marijuana in New Jersey. 81% of cannabis business owners are white and only 4.3% Black. But black people are 264% MORE likely than white people to be arrested for cannabis possession. Orange's demographic is predominantly minorities. It is our job as a small town to make a change now, banning cannabis business will only take us a step backwards.
