WHEREAS, the City Council desires to adopt its annual meeting schedule.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Orange Township that, in accordance with N.J.S.A. 40:69A-179 and Chapter 4, Article II, § 4-9 of the Code of the City of Orange Township, the attached annual schedule of the City Council meetings is hereby adopted.

BE IT FURTHER RESOLVED that in accordance with N.J.S.A. 10:4-6, the City Clerk is hereby directed to post the attached schedule of the City Council meetings on the City Hall bulletin board, the City and City Council websites, and send copies to the official newspapers.

BE IT FURTHER RESOLVED that, from time to time, there may be a need for special meetings and emergency meeting as may be deemed necessary for the transaction of business, and upon being advised of the need for such meeting, the Office of the City Clerk shall publish and post notification of such meeting in accordance with the requirements established by the Open Public Meetings Act and such other laws and regulations as may be applicable.
