MATTERS FOR DISCUSSION

New Voting Machines:

- A pre-recorded voter outreach video from the Essex County Superintendent of Elections was played for the Municipal Council and citizens. The video can be seen on the Council's website under Elections.

Vincent DeFilippo, City of Orange's Health Officer discussed the following updates regarding COVID-19:

- There are five (5) testing sites in the City of Orange Township.
- Redeemed Christian Church of God located at 180 Main Street will be administering vaccines on Sunday, June 6th at.
- St. Matthews A.M.E. Church located at 336 Oakwood Avenue will be administering vaccines on Friday, June 4th.
- Governor Murphy ended the social distancing and mask requirements as of Friday, May 30th.
- Essex County College is still administering the following vaccines.
 - o Moderna from 10:00 a.m. to 2 p.m.;
 - o Johnson & Johnson from 1:30 p.m. to 2:00 p.m.; and
 - o Pfizer from 3 p.m. to 4 p.m.
- Essex County has administered 355,000 vaccines (7,000 Johnson & Johnson and to 319 homebound residents).
- At least 47% of Orange residents have been vaccinated.
- Vaccine clinic at Our Lady of Mount Carmel Church located at 103 South Center Street on Saturday, June 12th.
- Vaccine clinic at Presbyterian Church of Ghana located at 510 Linden Place on Thursday, June 10th.
- Commencement of tick season and urged residents to wear closed shoes, white socks and check their dogs and cats for ticks.
