WHEREAS, the City of Orange Township did duly advertise on November 19, 2021 for proposals for car washing services to all City Owned vehicles pursuant to the specifications; and,

WHEREAS, on December 7, 2021 the City of Orange Township received one (1) public proposal for car washing services from the following:

WHEREAS, there exists a need for car washing services within a 3 mile radius of the City of Orange Township since physical proximity is necessary for the economical performance of the contract; and


WHEREAS, the Director of Public Works did examine the proposal and determined that KC's Car Wash's proposal complied with the Local Public Contracts Law; and,

WHEREAS, KC's Car Wash has completed and submitted a Business Disclosure Certification which certifies that it has not made any reportable contributions to a political or candidate committee in the City in the previous one (1) year, except that the year 2005 is an exception to this requirement as the one year immediately proceeding the effective date of the Law, as that term is defined below, and that the contract will prohibit KC's Car Wash from making any reportable contributions throughout the term of the contract; and,

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto, certifying that funds will be available for this purpose in Account No. 2-01-26-315-000-528, contingent upon Council approval and inclusion of said item in the Temporary Budget and adopted 2022 Budget, there will be sufficient funds to contract with KC's Car Wash.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Council of the City of Orange Township, that a contract be awarded to KC's Car Wash, 360 Thomas Blvd, Orange, New Jersey 07050; and,

AGREEMENT

This Agreement, made and entered into this day of,

WHEREAS, the City of Orange Township wishes to retain a firm for the purpose for car washing services to all City owned vehicles in the City of Orange Township, as specifically set forth in the attached specifications in the amount not to exceed \$8,000.00.

WHEREAS, the City of Orange Township wishes to retain KC's Car Wash with offices located at 360 Thomas Boulevard, Orange, New Jersey 07050, the lowest responsible bidder of bidders to submitting for such service on December 7, 2021.

WHEREAS, this firm and the individuals of the firm are to be retained pursuant to the Agreement as specified by the attached specifications dated December 7, 2021; and

WHEREAS, the City Council of the City of Orange Township has, by				
Resolution #	dated	, authorizes KC's Car Was for		
providing car washing services to all City owned vehicles specified in the attached				
specifications.				

NOW, THEREFORE, BE IT AGREED by and between the parties, for the mutual convenient set forth herein below:

- 1. **KC's Car Wash** is hereby contracted by the City of Orange Township to provide services as specified in the attached specifications.
- 2. This agreement shall be effective commencing on January 1, 2022 through December 31, 2022.
- 3. This agreement shall not be assigned nor shall any duties under this agreement be delegated by KC's Car Wash without prior written consent of the City.



- 4. The validity of this agreement and its terms or provisions, as well as the rights and duties of the contracting parties, shall be governed by and construed in accordance with the laws of the State of New Jersey.
- 5. This agreement shall be binding on and inure to the benefit of the contracting parties and their respective heirs, executors, administrators, legal representatives, successors, and assigns when not expressly prohibited by this agreement.
- 6. In case any one or more of the provisions contained in this agreement shall for any reason be held to be invalid, illegal or unenforceable in any respect, the invalidity, illegality, or unenforceability shall not affect any other provision of it this agreement shall for any reason be held to be invalid, illegal, or unenforceable provision had never been contained in it.
- 7. This agreement constitutes the sole agreement of the contracting parties and supersedes any prior understandings or written or oral agreements between the parties respecting its subject matter.
- 8. All notices and other communications shall be sent by certified mail, return receipt requested, and shall be deemed to have been given when sent to the parties at their respective addresses as set forth above, unless a different address has been selected after the execution of this agreement and has been duly communicated to the party giving notice.
- 9. The City may terminate this Agreement upon three days notice with American Wear, Inc. In the event that this agreement is deemed to be terminated, the City shall pay KC's Car Wash for those services provided as of the effective date of termination.
