**TITLE:** **A RESOLUTION OF THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, COUNTY OF ESSEX, STATE OF NEW JERSEY, AUTHORIZING A COOPERATIVE PURCHASING AGREEMENT FOR SERVICES WITH JOHNSTON COMMUNICATIONS INC. TO PROVIDE TELEPHONE AND ASSOCIATED SERVICES SYSTEMS EQUIPMENT, INSTALLATION, AND MAINTENANCE SERVICES FOR THE CITY OF ORANGE TOWNSHIP POLICE DEPARTMENT, FROM JANUARY 1, 2022, UNTIL DECEMBER 31, 2025, IN AN AMOUNT NOT TO EXCEED \$2,598,397.35.**

**WHEREAS,** the City of Orange Township ("City") is authorized under the Local Public Contracts Law to enter into agreements with vendors through approved cooperative purchasing programs; and,

**WHEREAS,** the City is a participating member of the Union County Cooperative Purchasing Program ("UCCPP"); and,

**WHEREAS,** the City seeks to enter a cooperative purchasing agreement with Johnston Communications Inc. ("Johnston"), 36 Commerce Street, Springfield, New Jersey, 07081, through the UCCPP, to install fixed cameras and automatic license readers throughout the City for use by the City's Police Department ("Police Department"); and,

**WHEREAS,** Johnston will provide video software, management and access systems, infrastructure improvements, as well as maintenance and support services as needed and required by the Police Department for a period beginning January 1, 2022, and continuing through December 31, 2025, in an amount not to exceed \$2,598,397.35; and,


**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF ORANGE TOWNSHIP, COUNTY OF ESSEX, STATE OF NEW JERSEY,** that a contract with Johnston for the purposes of providing video software, management and access systems, infrastructure improvements, and maintenance and support services is hereby approved for a period beginning January 1, 2022, and continuing through December 31, 2025, in an amount not to exceed \$2,598,397.35; and,

**BE IT FURTHER RESOLVED,** that the Mayor is hereby authorized to execute the agreement with Johnston to provide said goods and services.
