TITLE: RESOLUTION RENEWING A PROFESSIONAL SERVICE AGREEMENT WITH LAMB KRETZER, LLC AS SPECIAL COUNSEL WITH REGARD TO VARIOUS LEGAL MATTERS AND LITIGATION INVOLVING JUDITH FELD, JEFFREY S. FELD THE FOUR FELDS, ETC. IN AN AMOUNT NOT TO EXCEED \$7,500.00 FOR CALENDAR YEAR 2022

WHEREAS, The Municipal Counsel of the City of Orange approved Resolution no. 73-2019 on March 5, 2019 authorizing a one (1) year professional service agreement for a total contract amount of \$20,000.00 with Lamb Kretzer, LLC, to represent the City of Orange Township; and

WHEREAS, Resolution no. 208-2020, approved on May 19, 2020 amended the professional services agreement to increase the contract amount by an additional \$10,000.00 with Lamb Kretzer, LLC; and

WHEREAS, Resolution no. 139-2021, approved on March 16, 2021 amended the professional services agreement to increase the contract amount by an additional \$20,000.00 with Lamb Kretzer, LLC; and

WHEREAS, the City awarded the contract Lamb Kretzer, LLC under the "fair and open process" of the Pay-to-Play Law, N.J.S.A. 19-44A-20.4 *et seq*; and

WHEREAS, the lawsuit is still ongoing and it is necessary to renew the contract and to increase the contract amount by an additional \$7,500.00; and

WHEREAS, Lamb Kretzer, LLC agreed to provide these services at an hourly rate of \$150.00, including expenses; and

WHEREAS, the Chief Financial Officer of the City of Orange Township has prepared the necessary Certificate of Availability of Funds, a copy of which is attached hereto certifying that funds will be available for this purpose in Account No. 2-01-20-155-000-519, contingent upon Council approval and inclusion of said item in the Temporary Budget and adopted 2022 Budget, there will be sufficient funds to contract Lamb Kretzer, LLC.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Orange Township, that the Addendum to the Agreement between the City of Orange Township and Lamb Kretzer, LLC is hereby approved in an amount not to exceed \$7,500.00

BE IT FURTHER RESOLVED that the Mayor Dwayne D. Warren, is hereby authorized and directed to execute the Addendum to the Agreement.
