# **Upper Main Street AINS Presentation by Nishuane Group**

Simran Riar, Junior Associate at Nishuane Group presented the Area In Needs Study for Upper Main Street. The purpose of the study was explained and how redevelopment plans benefit the city. This study is a non-condemnation plan and therefore, eminent domain will not be used. The purpose of this study is to determine whether the area will need redevelopment and/or rehabilitation.

The study contains thirty-one (31) parcels and is within the North and West Wards of the City of Orange Township. The criteria was described for the Area in Need of Redevelopment. The study incorporates a block by block analysis of all properties in question.

The conclusion found is that all of the parcels that lie therein meet at leasat one criterion of the LRHL statutory criteria. The study area has a large commercial component, with residential and public uses supporting and/or being supported by these businesses. It is recommended that a Redevelopment Plan also be initiated for Upper Main Street to open up pathways to repairs, improvement of conditions and to better facilitate the growth of the area by outlining goals for future development.
