TITLE: AN ORDINANCE TO AMEND THE CODE OF THE CITY OF ORANGE TOWNSHIP, CHAPTER 200, ENTITLED "VEHICLES AND TRAFFIC" SECTION 200-52-1 HANDICAPPED PARKING SPACES. (26 NORTH JEFFERSON ST)

WHEREAS, Tomika Smith has in her possession a special identification card issued by the Division of Motor Vehicles of the State of New Jersey; and

WHEREAS Tomika Smith requested that a handicapped parking space be established in front of his house; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Orange Township that Section 200-52-1 be and is hereby amended to include a handicapped parking space at the location as follows:

26 North Jefferson St

BE IT FURTHER ORDAINED that any ordinances or parts thereof in conflict with the provisions of this ordinance are repealed to the extent of such conflict.

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon final passage, approval and publication pursuant to law.


