ORDINANCE OF THE CITY OF ORANGE TOWNSHIP, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY (THE "CITY") PROVIDING FOR A SPECIAL EMERGENCY APPROPRIATION IN THE AMOUNT OF \$600,000 TO FUND CONTRACTUALLY REQUIRED SEVERANCE LIABILITIES RESULTING FROM THE RETIREMENT OF EMPLOYEES IN THE CITY

WHEREAS, N.J.S.A. 40A:4-53(h) provides that a local unit such as the City of Orange Township, in the County of Essex, New Jersey (the "City"), may adopt an ordinance authorizing a special emergency appropriation for the payoff of contractually required severance liabilities resulting from the layoff or retirement of employees of the City; and

WHEREAS, pursuant to N.J.S.A. 40A:4-53(h), the City desires to authorize a special emergency appropriation in the amount of \$600,000 to fund the cost of contractually required severance liabilities resulting from the retirement of employees.

BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF ORANGE TOWNSHIP, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY (not less than the majority of all members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1. Pursuant to N.J.S.A. 40A:4-53(h), the amount of \$600,000 is hereby appropriated to fund the cost of contractually required severance liabilities resulting from the retirement of employees, and shall be deemed a special emergency appropriation as defined and provided for in N.J.S. 40A:4-53. The severance liabilities shall be paid without interest and, at the sole discretion of the City, may be paid in equal annual installments over a period not to exceed five (5) years.

SECTION 2. To finance the appropriation authorized hereunder, and described in Section 1 hereof, special emergency notes of the City (the "Notes") shall be authorized by a resolution of the City Council of the City to be adopted in accordance with the provisions of N.J.S.A. 40A:4-55.

SECTION 3. This ordinance shall take effect twenty (20) days after final adoption and approval by the Mayor. A certified copy of this ordinance shall be filed with the Director of the Division of Local Government Services, New Jersey Department of Community Affairs.
